**Background:** The 2022 General Election was held on November 8, 2022 in Precinct 1, Precinct 2, Precinct 3, and Precinct 4, in the City of Shorewood. The Election included City Council (2) seats. The City’s Canvassing Board must approve the official election results at a Canvassing Board Meeting between three and ten days of the General Election and the City Clerk must certify that all of the ballots cast at the General Election were carefully tabulated and that the number of votes marked opposite the respective names of the candidates or propositions, correctly shows the number of votes cast.

The special Election Canvas Board meeting is set for Monday, November 14, 2022 at 7:00 p.m. which will be directly followed by the Regular City Council Meeting.
