WORK SESSION

• Follow up on Burch Creek Field RAMP Grant discussion. Staff will be presenting a recommendation to the council regarding a RAMP grant request to make improvements to the fields at Burch Creek Park. The council's direction has been to apply for a regular grant for this project. Regular grant applications can request funding up to \$199,999.

- Use of American Rescue Plan Act (ARPA) Funds Discussion. This will be an opportunity for the council to better understand the amount of money the city received as a part of the ARPA. We will also review some of the upcoming large capital projects/equipment obligations the city needs to address in the coming years. Steve has provided a spreadsheet listing some of these items and their estimated costs. During this meeting, staff wants to be sure to familiarize the council with these funds and the projects, etc. and over the next several months we will be working with the council to formulate a plan on how you'd like to allocate the ARPA funds, as well as pay for some of the other large capital needs.
- 2023 Community Survey Preliminary Results.

The 2023 Community Survey wrapped up with a total of 565 residents completing the survey. I've included a copy of the preliminary report for your review. Staff will be finalizing the report as well as creating a report showing how the 2023 results compare with previous year's reports. This information is meant to help you as a council gain a better understanding of how the residents perceive the services being provided by the city and what they believe the council should be focused on in the coming years. This information, along with information provided by city department directors in the coming weeks, will prepare the council for the 2024 Strategic Plan Retreat.

Below are a few highlights from the data that may be of interest. I've also created some crosstabulation reports (packet after the survey data) that may be of interest. The openended question responses below were analyzed using ChatGPT to try and identify themes in the responses and to organize the data. Based on a population size of 17,500 and a

sample size of 565 survey respondents, this data has a margin of error of \pm 4% and a confidence interval of 95%. This means that we can be 95% confident that if every resident took the survey, their responses would be within 4% (higher or lower) of the survey responses.

When asked (question 39) what residents would like the council to focus on in the coming years, their responses included ideas such as:

- o Improving local infrastructure.
- o Enhancing community safety.
- o Promoting economic development.
- o Improving public amenities.
- o Fostering community engagement.

These areas reflect the key interests and concerns of the residents regarding the growth and development of the city.

When asked if they were in, what would they change about South Ogden City, residents responded with a variety of changes they would like to see in the city (question 40). These suggestions include:

- 1. **Improved Access to Amenities**: Requests for closer grocery stores and additional facilities like a public recreation center and a senior center.
- 2. **Community Development and Housing**: Many residents expressed a desire to limit the growth of apartments and promote more diverse businesses. There's also a call for better parking solutions for existing apartment buildings.
- 3. **Public Safety and Infrastructure**: Enhancing road safety, better policing, and more effective crime addressing in neighborhoods are prominent concerns. Additionally, there's a desire for improved road maintenance and infrastructure.
- 4. **Community Engagement and Services**: Suggestions include the addition of arts venues, green waste sites, and improving the availability of services like animal control during weekends.
- 5. **Environmental and Health Initiatives**: Requests for better walkability through connected sidewalks, improved public transportation, and promotion of sustainability and health.
- 6. **Legal and Regulatory Changes**: Some residents want changes in laws, such as allowing chickens, adding speed bumps on streets, and better code enforcement.
- Communication and Community Involvement: A desire for better communication from city officials and more involvement of residents in decision-making processes.
- 8. **Economic Development**: Attracting high-quality commercial entities related to industries like tourism, outdoor activities, and federal contracting to create high-salary jobs.

When asked what other comments or insights residents would like to share with the council, residents provided the following input (question 38):

- 1. **Community Amenities and Facilities**: Suggestions for a river splash pad, more restaurants, and improved city facilities like parks and playgrounds.
- 2. **Housing and Development Concerns**: Concerns about the proliferation of apartments, with calls to limit their growth, improve street conditions, and focus on the quality of life for current residents rather than just adding more rental units.
- 3. **Infrastructure and Safety**: Requests for solar speed signs, better road maintenance, and accessible sidewalks with ramps.
- 4. **City Governance and Community Involvement**: Appreciation for the city's efforts in certain areas, but also expressions of feeling unheard or ignored in city council meetings. Some residents feel that the city is moving away from its unique characteristics due to overbuilding and traffic issues.
- 5. **Communication and Information**: A desire for improved communication channels, such as a South Ogden Instagram account, and addressing false information in the community.
- 6. **Environmental Concerns**: Worry about the loss of green spaces and natural areas due to development, highlighting the need for preserving these spaces.
- 7. **Community Spirit and Satisfaction**: Many residents express love and satisfaction with living in South Ogden, while some are concerned about future changes and their impact on the city's character.
- 8. **Animal Policies**: Repeated requests to allow chickens in the city and to let dogs in parks.
- 9. **Miscellaneous Suggestions**: Various other suggestions include improved services for senior citizens, more attention to downtown areas, and addressing specific community issues like the removal of pride flags from homes.

CONSENT AGENDA

Advice and Consent Items. With Councilmember Howe's election to the city council, it creates a vacancy on the Planning Commission. Mayor Porter has interviewed and is recommending Eric Lee to serve on the city's Planning Commission. Additionally, planning commissioner, Brian Mitchell's term has expired, and Brian has expressed a desire to remain on the commission for another term. Brian was appointed six months ago to complete Angela Snowden's term when she stepped down.

DISCUSSION/ACTION ITEMS

- Rules of Procedure Review/Amendments. Staff will be reviewing the rules of procedure with the council. Primarily the focus will be to provide training to new council members, but it will also serve as a reminder to all council members of the rules and procedures that govern the city council meetings. While reviewing these for the meeting, staff is also recommending that language be added to these rules that describe the annual process of reviewing and making council assignments. It is recommended that these processes be spelled out within the council Rules of Procedure to ensure consistency of the process from one year to the next, as well as from one mayor and council to the next.
- Councilmember Assignments. Mayor Porter will be reviewing the different opportunities for the council to serve on various boards, commissions, committees, etc. with the intent to appoint members of the council to each board/committee for 2024. A list of the boards, committees, etc. has been provided in the packet, as well as who has been representing the city.

SOUTH OGDEN ARTS COUNCIL

• 2024 RAMP Grant. Each year, prior to applying for the arts portion of the RAMP grant program, the Arts Council must meet to review and make a recommendation as to what the grant will be used for. Typically, the Arts Council recommends seeking funds to help support South Ogden Days. For many years, South Ogden requested \$10,000 to help pay for the entertainment. Last year, this request was increased to \$25,000 and the city was awarded \$22,000. Staff recommendation is to apply for \$25,000 again this year. Jamie Healy, Communications and Events Coordinator will be attending the meeting and available to answer questions about this year's South Ogden Day and/or the RAMP grant application.





We expressed concern about the speeding and red light abuse at the intersection of Washington and 1050 E., as well as at other points on Washington. The police responded immediately. NOTE: Many drivers in South Ogden and other surrounding communities, exhibit selfishness, and poor driving habits. Especially bad is the tendency to weave in and out of lanes, cutting in front of another driver, without signaling (frequently to make a right turn), and using the horn to abuse other drivers. I've seen these and other bad-driving occurrences regularly, and have experienced them too.

She was gone way longer than 15 minutes and there was like 5 witnesses there so could attest to it. You can't leave children under 12 in a car alone and I wouldn't even leave my 12 year old alone. I ended up feeling like the bad guy and he basically just told her not to do it again and she just drove off in her car. He was very nonchalant about the whole thing and somewhat rude to me.


The rec department is organized and they have great refs/officiators. It would help to have a little more time knowing about the first games (coach packets get out sooner?), but overall it's an awesome experience!


Q39 - Click on the map region which contains the location of your home.



Q26 - What is your age




Q27 - What is your ethnic background?








Need a mayor and council that care about the downtown district. Not just lip-service.

Rules of Procedure for City Meetings

Last Updated 06 Dec 2022

The "Body" (City Council, Planning Commission, etc.) may adopt any rules it deems necessary to the efficient conduct of its meetings.

Basic Policies for South Ogden City Meetings

- 1. For City Council matters, the Mayor, any Council Member, or the City Manager can place an item on the City Council agenda.
- 2. For other bodies, any member of that Body may place an item on the agenda.
- 3. An item scheduled for the agenda can be rescheduled for a different date by a majority of the members of the Body.
- 4. The Chair must recognize Members wishing to make a motion or enter a debate in the order in which they request recognition.
- 5. The Chair must ask for a motion and a second to the motion on each item on the agenda. Any motion receiving a second will be discussed by the Body.
- 6. Any Member may call for the question at any time. A vote will then be held on the motion.
- 7. Any document adopted and passed that requires signatures will be signed at the meeting, prior to adjournment. If the Chair refuses to sign the document(s), any three Members may execute the document on behalf of the Body.
- 8. Member packets will be distributed before a scheduled meeting.
- 9. All meetings are open and public meetings unless specifically closed under the provisions of the Utah Open Meetings Act.
- 10. A public meeting is defined as a meeting at which public business is discussed, decided or policy formulated. Citizens are allowed to attend and observe but not necessarily participate.
- 11. A public hearing is defined as a meeting which provides citizens the opportunity to express their position on the issue under consideration, both pro and con after due notice. Citizens may observe and comment as provided by the Body's rules but this is not a forum for a debate with the Body.

- 12. Citizens' comments will be taken at the beginning of the meeting. Any citizen, who wants to make comments will have the opportunity to do so in an orderly manner. This opportunity to make a comment is not to be mistaken for a public hearing nor is it an opportunity to debate with the governing body. Responses to public comments by elected officials and/or staff may be permitted by the Chair, recognizing no decisions or policies may be adopted during public comment time. The Body will not tolerate any interruptions or disruption of meetings. Each citizen may speak once for a period not to exceed three (3) minutes.
- 13. Any citizen desiring an item be placed on an agenda should submit, in writing, a description of the proposed agenda item, a rationale for placing the item on the agenda, and all background information needed for the Body to make a decision. The City Manager, or his/her designee, will inquire whether any member of the appropriate Body is willing to sponsor the item for the agenda. Sponsored items will be placed on the agenda for the next meeting of that Body. Non-sponsored items will not be placed on the agenda. Items to be placed on the agenda are due by noon at least three working days before regularly scheduled Meeting.

Rules for Conducting Public Hearings

- 1. All members of the public will be allowed to speak once for a period not to exceed five minutes.
- 2. If a comment or question from a member of the Body interrupts a member of the public speaking during a hearing, the time taken by the comment or question and the response will not be counted as part of that citizen's five minutes.
- 3. If a member of the Body raises a question about a comment from a member of the public after the person has made his/her comments, the member of the public will be allowed two minutes to respond to each question raised.
- 4. Members of the public cannot give their five minutes away to another person to speak on their behalf.
- 5. A member of the public, during the time allotted for that person's comments, may request of the Body that the record be held open for written comment. Any member of that Body may then move to hold the record open for written comments for a specified period. If the motion receives a second and passes by majority vote, the record will be held open for the specified time, otherwise the item will not be received into the record.
- 6. Participants in public hearings will be expected to conduct themselves with civility. Speakers must be courteous. **Applause is not allowed**. Outbursts from those attending a public hearing will not be tolerated. When a member of the public has been recognized and is speaking, he/she has the floor. Other members of the public may not speak either to the speaker or members of the Body until they have been given the floor. Spontaneous comments or other outbursts from the public will not be allowed.

Rules for Conducting Electronic Meetings

- 1. Any meeting of the Body may be called and held electronically provided such meeting is otherwise called in conformance with the Utah Open and Public Meetings Act found in Utah Code Title 52, Chapter 4, and consistent with the procedures set forth herein.
- 2. The City main office at 3950 South Adams Avenue, South Ogden, Utah is where Body meetings would normally convene and will be the anchor location for all electronic Body meetings. The City finds that such chambers prove space and facilities so interested persons and the public may attend and monitor the open portions of meetings of the Body, whether such meeting is a public hearing or otherwise.
- 3. A meeting may be held by using computer and/or telephone conferencing to allow a member of the Body, subject to the open meeting requirements of Utah, to be present at a meeting. A quorum consisting of a simple majority, must be present at the anchor location. There will be a limit of only two electronic connections at any meeting. Any member of the Body participating via electronic means may make, second and vote on all motions and participate in the discussion as though present. Except for a unanimous vote, a public body that is conducting an electronic meeting shall take all votes by roll call.
- 4. To provide for electronic meeting attendance, public notice of such meeting must be given at least 24 hours before the meeting by (i) posting written notice at the anchor location; and (ii) providing written or electronic notice to (a) at least one newspaper of general circulation within the State and in the City; or (b) to a local media correspondent; and (c) the state's public notice website; and (iii) providing notice of the electronic meeting to the members of the council or board at least 24 hours before the meeting so they may participate in and be counted as present for all purposes; and (iv) providing each member of the public body a description of how to electronically connect to the meeting.
- 5. A request for electronic meeting attendance made by a member of the council or board may be made up to three days, but not less than twenty-four hours, prior to the scheduled meeting to allow for public notice provisions. Requests to attend meetings electronically must be made to and approved by the Mmayor or chairperson of the affected board or commission.

Disturbing Meetings

The City Council may fine or expel, and other Bodies meeting on behalf of the city may expel, any of its members for disorderly conduct upon an affirmative "majority plus one" vote of those members present. The Body may also, upon an affirmative majority "majority plus one" vote of those members present, expel any person who is disorderly during any regular, work or special meeting of the Body.

The Chair may expel any person, other than a member of the Body, who is disorderly during any regular, work or special meeting of the body.

Notes on Decorum in Discussion/Debate Generally:

A loose paraphrasing of *Robert's Rules of Order* (Ninth Edition) suggests the following guidelines in helping to maintain civility and fairness during discussion and debate. These guidelines are pertinent when controversial issues arise in discussion.

1. Treat one subject at a time

Do not speak adversely on a prior action that is no longer pending: In debate, a member cannot reflect adversely on any prior act of the body not then pending, unless a motion to reconsider, rescind, or amend it is pending, or unless s/he intends to conclude his/her remarks by making or giving notice of one of these motions.

2. Alternate between opposite points of view in discussion unless it is clearly apparent there is unanimous support for the question under discussion.

Fairness, and the appearance of fairness is vitally important to success and effectiveness in the deliberative process.

3. Maintain decorum in discussion and avoid allowing personalities to enter into the debate

Do not attack a member's motives: When a question is pending, a member can condemn the nature or likely consequences of the proposed measure in strong terms, but should always avoid discussions of personalities, and under no circumstances should s/he attack or question the motives of another member. The measure, not the member, is the subject of debate.

Avoid personalizing issues. The phrase "attack issues, not people" summarizes the goals of discussing and debating matters brought before a deliberative body. Any personal remark or attack must be ruled out of order by the chair: "Bob is a whiny anarchist and for that reason I cannot support his motion" is a comment that must be stricken and called up short immediately. Remarks must be kept free of personal reference.

The motion being considered is the subject of debate, not the member who proposed it. Offensive language is by definition offensive and all remarks must avoid personal invective.

Address all remarks through the chair: it is best practice if members of a deliberative body do not address one another directly, but address all remarks through the chair. This is an effective tool in keeping away from the likelihood of sliding into personalizing an issue. If, while a member is speaking in discussion or debate, another member wishes to address a question to him/her. . . the member desiring to ask the question should address the chair, proceeding as... [a] Point of Information ...

4. Confine debate to the merits of the question under discussion.

Confine remarks to the merits of the pending question. In a discussion and debate a member's remarks must be germane to the question then before the body.

Members should refrain from speaking adversely on or about a prior action that is not pending. In debate, a member cannot reflect adversely on any prior act of the society that is

not then pending, unless a motion to reconsider, rescind, or amend it is pending, or unless he intends to conclude his remarks by making or giving notice of one of these motions.

5. Division of a question—members may be for one part of a question and not for another.

COUNCIL APPOINTMENTS TO BOARDS AND COMMITTEES

- 1. At the first meeting of each new calendar year, the City Council will nominate and elect a Mayor pro-tem, who shall act in the Mayor's stead in leading and conducting council meetings in the case the Mayor is unable to attend, either in person or electronically.
- 2. At the first meeting of each new calendar year, the Mayor shall appoint, by the advice and consent of the City Council, members of the City Council to represent South Ogden City on various outside boards and committees, e.g. Ogden Weber Chamber, Weber County Mosquito Abatement Board, Bonneville Communities That Care, etc.
