6. **Legal & Professional Expenses**

When the DRB requires legal counsel, engineering, or other professional services to render a decision, 75% will be incurred by the applicant and 25% by the Town of St. Albans upon Select Board or Town Attorney approval.

5. **Penalties**

Upon failure to obtain a building permit *before* construction, subdivision, change or commencement of use has begun an additional fee of \$100.00 or 100% of permit cost (whichever is greater) will be assessed.

If a Notice of Violation is issued an additional fee of \$200.00 or 100% of permit cost (whichever is greater) will be assessed.

6. **Town Plan or Zoning Bylaw Change/Amendment** **\$1000.00**
(unless otherwise exempt as per statute)
