6. Financials: Finance/Budget Officer: Kim Thacker

Mrs. Kim Thacker presented the financial reports for the month of July for both the general fund and water fund.

Mrs. Thacker then noted the following changes to the Budget message:

Page 1: Highway 220 was changed Interstate 73

Page 2: REVENUES: first 2 sentences were changed to read - General Fund Revenues for Fiscal Year (FY) 2022-2023 are estimated at \$794,737.50. The town receives \$158,690.11 from the Water Enterprise Fund as a reimbursement for shared expenses paid from the Town's General Fund.

Page 2: end of same paragraph, sentence added: The town has been awarded funds from a federal grant from the State and Local Fiscal Recovery Fund also, known as the American Rescue Plan (ARP) in the amount of \$362,737.50.

Page 2: EXPENDITURES: changed to read: General Fund Expenditures for the Fiscal Year (FY) 2022/2023 are budgeted to be \$953,427.61. General Fund revenue of \$794,737.50 coupled with the reimbursement of \$158,690.11 from the Water Enterprise Fund for shared expenses paid in full for the General Fund represent a balanced General Fund budget for FY 22/23.

Page 3: corrected House Bill # to read 1136

Page 3: removed the last sentence: Legislation is currently being discussed which would delay the Town's requirement to encumber or spend these funds until June 2023.

Mayor Pro Tem Foy made a **Motion** to adopt the revised Budget Message and place on the Town's website.

Councilman Jones seconded the motion and <u>Amended</u> the motion to include the date 8-11-2022 added to the end of the Message.

He noted that Stokesdale does not receive sales tax revenues and will investigate ways to remedy that overall.

Mayor Pro Tem Foy mentioned Caldwell County's arrangements for distributing sales tax and asked that, if elected, he might investigate that possibility.

Councilman Landreth asked if he was in favor of a tax increase. Mr. Mobley stated not generally but would depend on how the money is to be spent.

RESOLUTION No. R-2022-02

A RESOLUTION CONSENTING TO THE ABANDOMENT OF A PORTION OF ANGEL PARDUE ROAD (SR 2102), LOCATED WHOLLY WITHIN THE CORPORATE LIMITS OF THE TOWN OF STOKESDALE, NORTH CAROLINA, FROM THE SECONDARY ROAD SYSTEM OF THE STATE OF NORTH CAROLINA

WHEREAS, Angel Family Limited Partnership, the property owners of this portion of Angel Pardue Road (SR 2102) have petitioned the North Carolina Department of Transportation to abandon 0.07 miles of said road from the State Maintained System as shown on the aerial map attached to and made a part of this Resolution as Exhibit A; and

WHEREAS, the North Carolina Department of Transportation has declared through a letter dated August 3, 2022, that the 0.07 mile portion of said road located on the property of Angel Family Limited Partnership should be abandoned from the Secondary Road System of the State of North Carolina; and

WHEREAS, the cognizant District Engineer of the North Carolina Department of Transportation does recommend the aforesaid Exhibit A description abandonment from the Secondary Road System of the State of North Carolina.

NOW, THEREFORE, BE IT RESOLVED THAT:

The Town Council on behalf of the Town of Stokesdale, North Carolina does herewith, after due consideration and deliberation and without any objection being heard, concur and consent to the abandonment of 0.07 miles of Angel Pardue Road, (SR 2102) from the Secondary Road System of the State of North Carolina to the same degree and measure to which Angel Family Limited Partnership has petitioned said Department of Transportation of the State of North Carolina; and to the same degree and measure to which the said Department of Transportation does now recommend abandonment from the said Secondary Road System of the State of North Carolina.

This the 11th day of August, 2022.


In May, the sheriff's office responded to a total of **204** calls for service in Stokesdale town limits, resulting in **20** formal case reports.

Town Administrator / Town Clerk

Proposed Job Description

The Town of Stokesdale is a small community located in the northwest corner of Guilford County and operates under the Mayor-Council form of government.

The Town Administrator / Town Clerk position serves as the primary point of contact for its Citizens. This position requires superior organizational, writing, and research skills along with the ability to communicate effectively with citizens, staff, and elected officials.

PRIMARY TASKS:

- 1. Manages and supervises the Town government staff; works with them to establish long and short range goals and ensures effectiveness and efficiency of services provided; communicates organizational mission, vision and goals as established by elected officials and Administrator and helps staff enhance these goals and implement programs consistent with them; builds a strong team among staff with energy and a cohesive vision.
- 2. Attend all regular and special meetings of the Town Council. In the event the Town Administrator/Town Clerk is unable to attend, to appoint a designee.
- 3. Maintains custody of official Town Council minutes, ordinances and resolutions and answers inquiries regarding Council action. Serves as custodian of public records including Code of Ordinance Book, Development Ordinance Book, contracts, agreements, deeds, and other public records. Prepares and/or publishes legal notices as required.
- 4. Attend all meetings of committees of the Town Council when requested to do so by a member of the Town Council and offer technical and clerical assistance as needed.
- 5. Broad knowledge of the Federal, State and Local Laws for Local Government.
- 6. Keep the Town Council advised of the town's financial condition and its future financial needs, and in cooperation with the Budget Officer/Finance Officer, assist with fiscal control duties in connection therewith as may from time to time be authorized by the Town Council.
- 7. Assist the Budget Officer/Finance Officer in the preparation of the annual budget.
- 8. Determine and manage the content of information posted on the Town website.

- 9. Direct and work with Guilford County Planning to administer, interpret and enforce town ordinances of record, and perform such other duties and functions as the Town Council may prescribe.
- 10. Seeks innovative methods of stewardship and new revenue sources; makes professional and realistic recommendations for expenditures of Town's funds; manages Town resources including budget, facilities, equipment, technology, town property, etc.; oversees and/or performs grant development and administration.
- 11. Oversees continuing education for Town Administrator, Clerk, and Finance Officer positions.
- 12. Coordinates and works with staff in ensuring policies, laws, and ordinances are legal, workable, enforced fairly, and consistently implemented.






