Bids for the construction of the Project will be received at the office of Sumter County Water Utility located at 1289 N. Main Street, Sumter, SC 29153, until Tuesday, April 15, 2025, at 10:30 a.m. At that time the Bids received will be publicly opened and read.

This project is funded in whole or in part through the SC Infrastructure Investment Program (SCIIP). All SCIIP program requirements, schedule deadlines, federal terms and conditions, and other applicable components of the SCIIP grant requirements are applicable to this project. For evaluation of bids and award of contract, see Instructions to Bidders.

The Project includes the following Work:

Base Bid

Replacement of 2 submersible well pumps (each 15-HP) and associated 3"-diameter column pipe, electrical, and controls; clean 2 existing wells (each 6"-diameter, 300' deep); replacement of well head piping and appurtenances at 2 wells; and replacement of filter media in 3 sand filters.

Additive Bid Alternates

Repainting of 3 sand filters and replacement of all sand filter piping, valves, and appurtenances; like-for-like replacement of 2 booster pumps (each 15-HP) and essential suction and discharge piping; add booster pump VFDs and replace booster pump controls, electrical, piping, valves, and appurtenances in treatment building; replacement of treatment building roof and doors; replacement of chemical feed system and associated controls, electrical, and appurtenances; replacement of treatment building raw water pipe and associated valves and appurtenances; replacement of miscellaneous gauges, valves, and other items on holding tank; repainting of holding tank; and tree removal.
