CALL TO ORDER: Chairman James T. McCain, Jr. called the meeting to order for Sumter County Council's meeting of March 27, 2018.

INVOCATION: The Clerk to Sumter County Council, Mary W. Blanding, gave the invocation.

NEW BUSINESS:

(1) <u>Recognition Of Malachi Coffey By The Honorable Anthony Dennis, Sheriff Of Sumter County And By Members Of Sumter County Council.</u>

Sheriff Anthony Dennis, presented a plaque to Malachi Coffey for saving the life of one of his neighbors. See information below which was presented by Sheriff Dennis. The Honorable Sheriff Dennis also allowed for Mr. Coffey to be pinned as a honorary Deputy and Department Manager for the day.

On behalf of myself and the Sumter County Sheriff's Office, we would like to take this opportunity to recognize Malachi Coffey for his heroic actions on Saturday, March 10, 2018.

Saturday started out as a normal day as it probably would for any of us. But it did not take long before it turned into a day that changed two lives forever. Allan Clemmons was working in his yard on his Mustang convertible that day and, as he attempted to remove the transmission, the car fell on him, trapping him underneath.



For the next hour and a half, Clemmons called out for help. "I asked God to help me, to give me one more holler and send an angel by my way," Clemmons said.



Meanwhile, in a nearby yard, 9-year-old Malachi Coffey was playing when he thought he heard someone crying out for help. You see, God heard Clemmons cry and sent him an Angel; a Little Angel with a Big Heart, Malachi Coffey!

As soon as Malachi witnessed what had happened he did not hesitate. He quickly grabbed a jack he saw lying nearby and pumped the handle desperately, while no doubt, saving the life of 65-year-old Allan Clemmons, who was severely injured. Once the jack had lifted the car off of Mr. Clemmons,

Malachi ran back to his aunt's house to get Clemmons some assistance.

Malachi, because of your split-second decision, you saved a life. I commend you for your quick thinking skills in an attempt to save someone else's life and this is why it is important that I take this moment to say thank you.

You see, it's this kind of quick thinking and heroic action that sets an example for all of us to follow. Please know that it is really commendable to the Sumter County Sheriff's Office and the Sumter Community for being so heroic.



After the Sheriff's presentation, the Chairman of Sumter County Council, presented Little Mr. Coffey with a proclamation and a trophy for being a great hero. See proclamation below.

It is known that a name can carry significant meanings as parents carefully and selectively name a child, such as the name of Malachi which means messenger or angel; and

Whereas,

Little would the parents of Malachi Coffey know that the



naming of their precious baby boy gave him a seal of great responsibility and attainability for someone his age; and

Whereas, Council is honored to recognize the "angel and messenger" known to us a Malachi Coffey for his heroic and selfless action to aid Mr. Allan Clemmons on March 10, 2018, during a time of dire need.

Whereas, Just at the right time, Malachi heard the call for help, responded to the call, and allowed his hands to be changed from that of a boy to the hands of a rescuer by using a jack to lift the fallen car from the chest of Mr. Clemmons.

Now Therefore Be It Resolved, that the members of Sumter County Council do hereby applaud Malachi Coffey for allowing himself to hear when it was time to hear, to move when it was time to move, and to run for help when it was time to run.

BE IT FURTHER RESOLVED, that we the members of Sumter County Council desire to place on record a testament of our appreciation for Malachi Coffey for his act of bravery by declaring that Wednesday, March 28, 2018, shall be known henceforth as Malachi Coffey Day, in Sumter County, South Carolina. (2) Recognition Of Sumter County Emergency Management Department.



Mr. Erik Hayes, Sumter County Emergency Management Director, introduced this matter before Sumter County Council. Mr. Hayes stated that this presentation is more about Risk Management and the reporting of those incidents by members of Sumter County Risk Management staff. Mr. Hayes introduced Mr. John Henderson who is the Director of Risk Management for the South Carolina Association of Counties Insurance Trust Department. Mr. Henderson stated that he is in attendance at this meeting of Council to present again a plaque to the staff of Sumter County for winning an award during the Annual Conference of the S. C. Association of Counties Worker

Compensation Insurance Trust and S. C. Property and Lability Trust Membership meeting held on January 5, 2018. This award was presented for the prompt reporting of property and liability claims. The County is the best in SCAC's entire program; this is the number one award; in other words, the Best of the Best. Mr. Henderson stated that Donna Dew reports these claims and Eric is the Risk Manager. Why is important; because as quickly as property reporting is completed, the quicker the settlement of a claim can occur. Settling the claim is very important and helps rates from going up quickly. Chairman McCain, Erik Hayes, and Donna Dew attended this conference on behalf of the Sumter County.

Council members thanked Eric Hayes and Donna Dew for their work and shining a light on the good work that is being done by the employees of this County.

COMMITTEE REPORTS:

(1) <u>Fiscal, Tax, and Property Committee Meeting To Be Held On Tuesday, March 27, 2018, At 5:30 p.m. In County Council Conference Room.</u>

Chairman McCain, the Chairman of the Fiscal, Tax, and Property Committee, reported that he and Councilman Edens were present at the meeting. However, Councilman McGhaney was absent due to illness. The Committee received an update concerning the Elliott Davis Company which will review the County's Tax Structure. The Finance Department, Treasurer's Department, Auditor's Department, and Assessor's Department are all involved in the review process. This report was for information only; no action was taken.

(2) Report From Council Members On Other Meetings, Trainings, And/Or Conferences; And Any Other Council Comments.

Councilman Baten stated that he is following the Local Government Fund (LGF) information that is being provided by the South Carolina Association of Counties (SCAC) in its Friday Report. It was noted in the Friday Report that the S. C. House indicated that "Not one crumb of additional Local Government Fund will be provided" this year to the counties. The S. C. House angrily rejected any view point opposing the House Ways and Means Report" as it relates to the LGF. It was also noted that the House of Representatives have suggested that "the LGF will be funded at the same level as last year (2017-2018)."

Councilman Baten also stated that on March 23, 2018, the budget went to the Senate. SCAC reported that it is now time to contact the Senators to ask for an increase in the appropriations for the Local Government Fund. Senator McElveen and Senator Johnson, Sumter County's two Senators, have always supported the LGF. Therefore, it must be noted that out of the full Sumter County Delegation, only one member does not support SCAC's request for full funding of the LGF.

Councilman Baten also met with Mr. Glen Peagler, the Director of the Sumter County Alcohol and Drug Abuse Commission. Mr. Peagler informed Mr. Baten that Sumter County as a whole, lost over \$200,000 in grant funds which would have helped with Opioid drug problems. This happened because the statistics shows that Sumter County does not have a serious Opioid drug problem. The \$200,000 that the County lost was because of not reporting the actual number of deaths that Sumter County has resulting from overdose of Opioids and Heroin drug related deaths.

SUMTER COUNTY RESOLUTION

A RESOLUTION AUTHORIZING (1) THE EXECUTION AND DELIVERY OF A FEE IN LIEU OF TAX AND INCENTIVE AGREEMENT BY AND BETWEEN SUMTER COUNTY, SOUTH CAROLINA (THE "COUNTY") AND A COMPANY IDENTIFIED FOR THE TIME BEING AS PROJECT BULLDOG, ACTING FOR ITSELF, ONE OR MORE AFFILIATES, AND/OR OTHER PROJECT SPONSORS (COLLECTIVELY, THE "COMPANY"), PURSUANT TO WHICH THE COUNTY SHALL COVENANT TO ACCEPT CERTAIN NEGOTIATED FEES IN LIEU OF AD VALOREM TAXES WITH RESPECT TO THE ESTABLISHMENT AND/OR EXPANSION OF CERTAIN FACILITIES IN THE COUNTY (THE "PROJECT"); (2) THE BENEFITS OF A MULTI-COUNTY INDUSTRIAL OR BUSINESS PARK TO BE MADE AVAILABLE TO THE COMPANY AND THE PROJECT; (3) CERTAIN SPECIAL SOURCE REVENUE CREDITS IN CONNECTION WITH THE PROJECT; AND (4) OTHER MATTERS RELATING THERETO.

WHEREAS, Sumter County, South Carolina (the "County"), acting by and through its County Council (the "Council"), is authorized and empowered under and pursuant to the provisions of the Code of Laws of South Carolina 1976, as amended (the "Code"), particularly Title 12, Chapter 44 of the Code (the "Negotiated FILOT Act") and Title 4, Chapter 1 of the Code (the "Multi-County Park Act" or, as to Section 4-1-175 thereof, and, by incorporation Section 4-29-68 of the Code, the "Special Source Act", and, together with the Negotiated FILOT Act, the "Act") and by Article VIII, Section 13(D) of the South Carolina Constitution: (i) to enter into agreements with certain investors to construct, operate, maintain, and improve certain projects through which the economic development of the State of South Carolina (the "State") will be promoted and trade developed by inducing manufacturing and commercial enterprises to locate and remain in the State and thus utilize and employ the manpower, agricultural products, and natural resources of the State; (ii) to covenant with such investors to accept certain fee in lieu of ad valorem tax ("FILOT") payments, including, but not limited to, negotiated FILOT payments made pursuant to the Negotiated FILOT Act, with respect to a project; (iii) to permit investors to claim special source revenue credits against their FILOT payments ("Special Source Credits") to reimburse such investors for expenditures in connection with infrastructure serving the County and improved or unimproved real estate and personal property, including machinery and equipment, used in the operation of a manufacturing or commercial enterprise in order to enhance the economic development of the County ("Special Source Improvements"); and (iv) to create, in conjunction with one or more other counties, a multi-county industrial or business park in order to afford certain enhanced income tax credits to such investors and to facilitate the grant of Special Source Credits: and

WHEREAS, a company identified for the time being as Project Bulldog, acting for itself, one or more affiliates, and/or other project sponsors (collectively, the "Company") proposes to establish and/or expand certain facilities at one or more locations in the County (the "Project"); and

WHEREAS, the Company anticipates that, should its plans proceed as expected, it will invest, or cause to be invested, at least \$150,000,000, in the aggregate, in the Project and will create, or cause to be created, at least 125 new, full-time jobs, in the aggregate, within the County; and

WHEREAS, on the basis of the information supplied to it by the Company, the County has determined, *inter alia*, that the Project would promote the purposes of the Act and would be directly and substantially beneficial to the County, the taxing entities of the County and the citizens and residents of the County due to the investment to be made, or caused to be made, and the jobs to be created, or caused to be created, by the Company, all of which contribute to the tax base and the economic welfare of the County, and, accordingly, the County wishes to induce the Company to undertake the Project by offering certain negotiated FILOT and multi-county industrial or business park benefits, as well as the benefits of certain Special Source Credits as set forth herein, and all of which shall be further described and documented in a Fee in Lieu of Tax and Incentive Agreement to be entered into by the County and the Company (the "Incentive Agreement").

NOW, THEREFORE, BE IT RESOLVED by the Council, as follows:

- <u>Section 1.</u> As contemplated by Section 12-44-40(I) of the Negotiated FILOT Act, the County makes the following findings and determinations:
 - (a) The Project will constitute a "project" within the meaning of the Negotiated FILOT Act; and
 - (b) The Project, and the County's actions herein, will subserve the purposes of the Negotiated FILOT Act; and
 - (c) The Project is anticipated to benefit the general public welfare of the State and the County by providing services, employment, recreation, or other public benefits not otherwise adequately provided locally; and
 - (d) The Project gives rise to no pecuniary liability of the County or incorporated municipality or a charge against its general credit or taxing power; and
 - (e) The purposes to be accomplished by the Project are proper governmental and public purposes; and
 - (f) The benefits of the Project are greater than the costs.

Section 2.

- (a) The County hereby agrees to enter into the Incentive Agreement with the Company, whereby the Company will agree to satisfy, or cause to be satisfied, certain investment requirements with respect to the Project within certain prescribed time periods in accordance with the Negotiated FILOT Act and the County, under certain conditions to be set forth in the Incentive Agreement, will agree to accept negotiated fee in lieu of *ad valorem* tax ("Negotiated FILOT") payments with respect to the Project.
- (b) (i) The Negotiated FILOT shall be determined using: (1) an assessment ratio of 4%; provided, that, in the event that the Expansion Project fails to qualify as an

"enhanced investment" under Section 12-44-30(7) of the Negotiated FILOT Act but nevertheless qualifies for a Negotiated FILOT under the Negotiated FILOT Act, an assessment ratio of 6% shall be applied retroactively and prospectively; (2) the lowest initial millage rate or millage rates allowed with respect to the Project pursuant to Section 12-44-50(A)(1)(d) of the Negotiated FILOT Act, which the parties presently believe to be [362.2] mills, and which millage rate or millage rates shall adjust every five years pursuant to Section 12-44-50(A)(1)(b)(ii) of the Negotiated FILOT Act for the full term of the Negotiated FILOT; (3) the fair market value of the Project, determined in accordance with the Negotiated FILOT Act; and (4) such other terms and conditions as will be specified in the Incentive Agreement, including, without limitation, that the Company, in its sole discretion, may dispose of property and replace property subject to Negotiated FILOT payments to the maximum extent permitted by the Negotiated FILOT Act.

(ii) The Negotiated FILOT shall be calculated as provided in this Section 2(b) for that portion of the Project consisting of "economic development property" under the Negotiated FILOT Act. For each annual increment of investment in such economic development property, the annual Negotiated FILOT payments shall be payable for a payment period of twenty (20) years, all in accordance with the Negotiated FILOT Act. Accordingly, if such economic development property is placed in service during more than one year, each year's investment shall be subject to the Negotiated FILOT for a payment period of twenty (20) years.

Section 3. The County will use its best efforts to ensure that the Project will be included, if not already included, and will remain, within the boundaries of a multi-county industrial or business park pursuant to the provisions of the Multi-County Park Act and Article VIII, Section 13(D) of the State Constitution on terms which allow the Company to seek from the State any additional jobs creation tax credits for the Project afforded by the laws of the State for projects located within multi-county industrial parks and on terms, and for a duration, which facilitate, the County's provision, and the Company's receipt, of the Special Source Credits referenced in Section 4 hereof.

Section 4. As an additional incentive to induce the Company to undertake the Project, and as reimbursement for investment in Special Source Improvements, and subject to the requirements of the Special Source Act and the terms and conditions of the Incentive Agreement, the County does hereby agree that the Company shall be entitled to receive, and the County shall provide, Special Source Credits against each FILOT payment, including, but not limited to, each Negotiated FILOT payment, due with respect to the Project for a period of ten (10) consecutive tax years, commencing with the tax year for which the initial Negotiated FILOT payment is due with respect to the Project, in an annual amount equal to twenty-five percent (25%) of such FILOT payment, all as shall be set forth in greater detail in the Incentive Agreement. In accordance with the Special Source Act, the Special Source Credits authorized herein shall not, in the aggregate, exceed the aggregate cost of Special Source Improvements funded from time to time in connection with the Project.

Section 5. The provisions, terms, and conditions of the Incentive Agreement shall be subject to approval by subsequent Ordinance of the Council. The Incentive Agreement is to be in substantially the form customarily used by the County for similar transactions with such changes therein as shall be approved by said Ordinance.

- <u>Section 6.</u> The Chairman of the Council, the County Administrator, and the Clerk to the Council, for and on behalf of the County, are hereby each authorized, empowered, and directed to do any and all things necessary or proper to effect the performance of all obligations of the County under and pursuant to this Resolution.
- <u>Section 7.</u> The execution and delivery of the Incentive Agreement is subject to the enactment by the Council of an ordinance authorizing the same and, in conjunction therewith, compliance with the provisions of the Home Rule Act regarding the procedural requirements for enacting ordinances.
- <u>Section 8.</u> All orders, resolutions, and parts thereof in conflict herewith are to the extent of such conflict hereby repealed. This Resolution shall take effect and be in full force upon adoption by the Council.

Congratulations! The Department of Homeland Security, Federal Emergency Management Agency (FEMA), has determined that Sumter County will increase to a Class 7 in the National Flood Insurance Program (NFIP) Community Rating System (CRS). The floodplain management activities implemented by your community qualifies it for a 15 percent discount in the premium cost of flood insurance for NFIP policies issued or renewed in Special Flood Hazard Areas on or after May 1, 2018. This increase is based on a field verification of your five-year cycle CRS application.

Please note Preferred Risk Policies, applicable in Zones B, C, and X, on your community's NFIP Flood Insurance Rate Map are not eligible for the CRS discount. Standard rated flood insurance policies in Zones B, C, X, D, AR, and A99 are limited to a CRS discount of ten percent in Class 1-6 communities and five percent in Class 7-9 communities. The rates for these zones already reflect significant premium reductions.

If there are no NFIP noncompliance actions, the CRS rating for your community will automatically be renewed annually and a notification letter will not be sent to your community. This Verification Report is provided to explain the recommendations of Insurance Services Office, Inc. (ISO) to DHS/FEMA concerning credits under the Community Rating System (CRS) for the above named community.

A total of 1596 credit points are verified which results in a recommendation that the community improve from a CRS Class 8 to a CRS Class 7. The following is a summary of our findings with the total credit points for each activity noted in parenthesis:

<u>Activity 310 – Elevation Certificates:</u> The Planning Department maintains elevation certificates for new and substantially improved buildings. Copies of elevation certificates are made available upon request. (14 points)

<u>Activity 320 – Map Information Service:</u> Credit is provided for furnishing inquirers with basic flood zone information from the community's latest Flood Insurance Rate Map (FIRM). Credit is also provided for the community furnishing additional FIRM information, flood depth data, and natural floodplain functions. The service is publicized annually and records are maintained. <u>Activity 330 – Outreach Projects:</u> Credit is provided an for informational outreach project that includes the Sumter City/County Flood Brochure available at various locations, and targeted outreach projects that include Repetitive Loss Outreach Letter and the Sumter City/County Flood Brochure sent to properties in the SFHA (Special Flood Hazard Area). These projects are disseminated annually. (96 points)

<u>Activity 340 – Hazard Disclosure:</u> Credit is provided for state and community regulations requiring disclosure of flood hazards. (10 points)

<u>Activity 350 – Flood Protection Information:</u> Documents relating to floodplain management are available in the reference section of the Sumter County Public Library. Credit is also provided for floodplain information displayed on the community's website. (47 points)

<u>Activity 420 – Open Space Preservation:</u> Credit is provided for preserving approximately 24 percent of the SFHA as open space. (372 points)

<u>Activity 430 – Higher Regulatory Standards:</u> Credit is provided for enforcing regulations that require development limitations, freeboard for new and substantial improvement construction, foundation protection, cumulative substantial improvement, protection of critical facilities, and local drainage protection. Credit is also provided for the enforcement of building codes, state mandated regulatory standards, and regulations administration. (499 points)

<u>Activity 440 – Flood Data Maintenance:</u> Credit is provided for maintaining and using digitized maps in the day to day management of the floodplain. (143 points)

<u>Activity 450 – Stormwater Management:</u> The community enforces regulations for stormwater management, soil and erosion control, and water quality. (112 points)

<u>Section 502 – Repetitive Loss Category:</u> Based on the updates made to the NFIP Report of Repetitive Losses as of January 31, 2017, Sumter County, SC has 2 repetitive loss properties and is a Category B community for CRS purposes. All requirements for a Category B community have been met. (No credit points are applicable to this section)

<u>Activity 510 – Floodplain Management Planning:</u> Credit is provided for the adoption and implementation of the Santee Lynches Hazard Mitigation Plan adopted May 26, 2015. A progress report must be submitted on an annual basis. An update to the credited plan will be due by October 1, 2020. (213 points)

<u>Activity 710 – County Growth Adjustment</u>: All credit in the 400 series is multiplied by the growth rate of the county to account for growth pressures. The growth rate for Sumter County, SC is 1.07.

The South Carolina Department of Transportation plans to replace the bridge on East Brewington Road near Sumter in Sumter County.

Replacement of the bridge is necessary due to the bridge being structurally deficient. This bridge is being replaced with a new 70 foot pre-stressed concrete bridge. The bridge will be closed on April 16, 2018, for approximately fifteen weeks. Pending any delays due to weather conditions, fabricator delays, etc., the bridge should be reopened to traffic by July 30, 2018.

Due to the relatively low traffic volumes, and in order to minimize the construction duration, cost, and impact to property owners in the area, the road will be closed and traffic detoured during construction. The current plan is for the detour to use roads S-43-41 (Eastern School Road), US 378 and US 76. We have included a map indicating the detour to be used. The net additional detour length will be approximately 4.9 miles.

Sumter County schools may be impacted and they will be informed of the pending road closure in order to reroute school bus traffic in the area. There are no major businesses that will be impacted.


