Minutes Sumter County Council Regular Meeting

Tuesday, June 11, 2019 -- Held at 6:00 p.m. County Administration Building -- County Council Chambers 13 E. Canal Street, Sumter, SC

COUNCIL MEMBERS PRESENT: James T. McCain, Jr., Chairman; James R. Byrd, Vice Chairman; Artie Baker, Eugene R. Baten, Charles T. Edens, Vivian Fleming McGhaney, and Chris Sumpter.

COUNCIL MEMBERS ABSENT: None

PUBLIC IN ATTENDANCE: Approximately 11 members of the public were in attendance.

CALL TO ORDER: Chairman James T. McCain, Jr., called the meeting to order.

INVOCATION: Councilman Vivian Fleming McGhaney gave the invocation.

PLEDGE OF ALLEGIANCE: All in attendance repeated the Pledge of Allegiance to the American Flag.

APPROVAL OF AGENDA: Regular Meeting Tuesday, June 11, 2019

Chairman McCain stated that he would entertain a motion to approve the agenda, if there were no additions or deletions to the agenda. The Clerk to Council informed the Chairman that there were no changes or corrections to the agenda.

ACTION: MOTION was made by Councilman Baten, seconded by Councilman Edens, and unanimously carried by Council to approve the agenda for Council's regular meeting of June 11, 2019, as presented.

APPROVAL OF MINUTES: Regular Meeting Tuesday, May 28, 2019

(Note: Council held budget meetings on May 28, 2019, and June 4, 2019, no action taken at the workshops.)

Chairman McCain stated that he would entertain a motion concerning the approval of the minutes of May 28, 2019, as prepared by the Clerk.

ACTION: MOTION was made by Councilman Sumpter, seconded by Vice Chairman Byrd, and unanimously carried by Council to grant approval of the minutes as presented.

LAND USE MATTERS AND REZONING REQUESTS:

Planned Development/Rezoning Requests

(1) <u>RZ-19-05 -- 526 Godwin Street (County) Third Reading -- Request To Rezone A +/-4.98 Acre Parcel Located At 526 Godwin Street From Residential-15 (R-15) To Agricultural Conservation (AC). The Property Is Represented By Tax Map # 245-06-02-003.</u>

Mrs. Helen Roodman, Zoning Administrator, stated that this request is to rezone approximately five acres of land from Residential-15 to Agricultural Conservation to allow the property to be in compliance with its current

usage. There have been no changes to this rezoning request from first reading. The Planning staff and Planning Commission recommended approval of the request as presented.

The Chairman asked Council members if they had any additional questions; there were no additional questions. Then the Chairman called for a motion on third reading.

ACTION: MOTION was made by Councilman Baker, seconded by Vice Chairman Byrd, and unanimously carried by Council for third reading.

(2) <u>RZ-19-06 -- 1449 Camden Highway (County) - Third Reading -- Request To Rezone +/-45.78 Acres Located At 1449 Camden Highway From Agricultural Conservation (AC) To Residential-15 (R-15). The Property Is Represented By Tax Map # 202-00-03-030 (Part).</u>

Mrs. Roodman also presented this proposed rezoning request to rezone approximately 46 acres of property from Agricultural Conservation to Residential-15 to allow for the development of a Subdivision. The Planning staff and Planning Commission recommended approval of the request as presented.

ACTION: MOTION was made by Councilman Baten, seconded by Vice Chairman Byrd, and unanimously carried by Council for third reading.

OTHER PUBLIC HEARINGS:

(1) 19-909 – An Ordinance Authorizing The Issuance And Sale Of General Obligation Bonds, Series 2019a, Or Such Other Appropriate Series Designation, In The Principal Amount Of Not Exceeding \$2,800,000; Fixing The Form And Details Of The Bonds; Authorizing The County Administrator To Prescribe Certain Details Relating To The Bonds; Providing For The Payment Of The Bonds And The Disposition Of The Proceeds Thereof; And Other Matters Relating Thereto. (Council Will Take Action On Third Reading Immediately After The Public Hearing Or During Old Business.)

The County Administrator stated that this ordinance is known as the County's Capital Bond Ordinance. The bond is up to \$2,800,000, and will be a private sale sometime in July. The list of bond items are shown under Old Business. Then the Chairman convened a public hearing. He asked if anyone wished to speak in favor of or opposition to the ordinance. No one spoke to this issue; therefore, the Chairman closed the public hearing and Council took action on this reading as listed under Old Business.

NEW BUSINESS:

(1) <u>It May Be Necessary To Hold An Executive Session To Discuss An Economic Development Matter, An Employment Matter, A Legal Briefing, Or Other Matters Pertaining To An Executive Session, And Take Appropriate Actions Thereafter If Required.</u>

No Executive Session was held.

OLD BUSINESS:

(1) 19-908 – Third Reading-- An Ordinance To Provide For A Levy Of Taxes For County Purposes Of Sumter County, S. C., (Known As The Budget Ordinance) For The Fiscal Year Of Said County Beginning July 1, 2019, To Direct The Expenditures Of Said Taxes And Other Funds Of Said County, And To Provide For Other Matters Related Thereto.

Mr. Mixon stated that Council is receiving a balance budget of \$51,908,042. The Budget includes the a 3% COLA for County Employees and funding request for other agencies. Mr. Mixon said that the funding for the Santee Lynches Regional Council on Governments' (SLRCOG – COG) construction project is not included in

the budget. He also said that the County Administrators in the four COG's County Region will be meeting to discuss what can be done about the COG's construction project.

Also included in this budget information a change to the Employee Handbook for travel reimbursement as cited by IRS and one change made in the Headcount for the Detention Center from 51 officers to 50 which was requested by the Sheriff.

ACTION: MOTION was made by Vice Chairman Byrd, seconded by Councilman Baker, and unanimously carried by Council for third reading and adoption.

(2) 19-909 – Third Reading — An Ordinance Authorizing The Issuance And Sale Of General Obligation Bonds, Series 2019a, Or Such Other Appropriate Series Designation, In The Principal Amount Of Not Exceeding \$2,800,000; Fixing The Form And Details Of The Bonds; Authorizing The County Administrator To Prescribe Certain Details Relating To The Bonds; Providing For The Payment Of The Bonds And The Disposition Of The Proceeds Thereof; And Other Matters Relating Thereto.

After a brief description of the items within the bond ordinance by County Administrator Gary Mixon, (see list below), the Chairman convened a public hearing. No one spoke during public hearing; therefore, the Chairman closed the public hearing and Council took action on third reading.

ACTION: MOTION was made by Councilman Baker, seconded by Councilman Sumpter, and unanimously carried by Council for third reading.

Resolution

R-19-01 -- A Resolution by Members of Sumter County Council Adopting Council's Actions On The 2019-2020 Budget Request Of Sumter School District.

Be It Resolved by the County Council for Sumter County, South Carolina, in Council duly assembled:

- 1. That in accordance with the general law and local law, any millage increase over the prior fiscal year millage must be approved by the governing body of Sumter County.
- 2. The provisions of §6-1-320(A)(1) of the Code of Laws of South Carolina, allow for an increase in millage, based on the consumer price indices for the prior calendar year and the percentage increase in the previous year in the population of Sumter County as determined by the Office of Research and Statistics of the State Budget and Control Board. The maximum permissible millage increase for fiscal year 2019-2020 is ___ mills which is ___ % of ____ mills.
- 3. That the annexed copy of the proposed budget (the Budget) for the Sumter School District, which was submitted for approval to the County Council for Sumter County, South Carolina, by the Sumter School District pursuant to the provisions of South Carolina Act 387 of 2008, as amended by Act 112 of 2009 of the General Assembly of the State of South Carolina, is, together with any changes or amendments heretofore made thereon, made a part hereof, and incorporated into this Resolution by reference.
- 4. That the annexed Budget, inclusive of any and all changes and amendments thereto heretofore made thereon as are reflected on the annexed copy thereof, is hereby approved by the County Council for Sumter County, South Carolina.
- 5. That the appropriate officials of Sumter County, South Carolina, are authorized and directed to determine, assess, levy, collect, and disburse the Ad Valorem taxes which will be generated by ______ mills, which Ad Valorem taxes will be approximately \$_____ million.
- Notwithstanding any other provision of this resolution, should the total millage needed to fund any other amount appropriated herein exceed the **millage approved herein**, the amounts appropriated herein shall be automatically reduced to the amounts actually generated by the approved millage rate of
