**TOWNSHIP OF TEWKSBURY
HUNTERDON COUNTY, NEW JERSEY
ORDINANCE NO. 06-2021**

**AN ORDINANCE OF THE TOWNSHIP OF TEWKSBURY, HUNTERDON
COUNTY, NEW JERSEY AMENDING ORDINANCE 19-2019**

WHEREAS, on December 10, 2019, the Township Committee of the Township of Tewksbury (the “Township”) adopted Ordinance 19-2019 authorizing the acquisition of a twenty-five percent (25.0%) undivided interest in an approximately 63.2 acre parcel of real property identified as Block 32, Lot 32.02 on the official Tax Map of the Township (the “Property”); and

WHEREAS, in addition to the Township, the Tewksbury Land Trust (“TLT”) was to acquire a seventy-five percent (75.0%) undivided interest in the Property; and

WHEREAS, Ordinance 19-2019 contemplated that the Township and TLT would enter into a management agreement for the Property that would assign deer management responsibilities to the Township; and

WHEREAS, since the acquisition of the Property, the Township and TLT have determined that it would be best for TLT to administer its own deer management program on the Property with the assistance of the Township.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Tewksbury, Hunterdon County, New Jersey, as follows:

SECTION 1. Ordinance 19-2019 is hereby amended to require that the Township and TLT enter into a mutually acceptable management agreement for the Property which assigns deer management responsibilities to TLT with the assistance of the Township.

SECTION 2. The Township Committee hereby authorizes the Mayor to execute, and the Township Clerk to witness, a management agreement and an amended Funding Agreement with TLT which reflect the assignment of deer management responsibilities on the Property to TLT.

SECTION 3. All actions of the Township taken prior to the date of adoption hereof contemplated by this Ordinance are hereby ratified and approved.

SECTION 4. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any remaining part thereof.

SECTION 5. All Ordinances or parts of Ordinances of the Township of Tewksbury heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 6. This Ordinance shall take effect immediately upon its final passage, approval and publication as provided by law.
