ORDINANCE NO. 08-2023**

**AN ORDINANCE OF THE TOWNSHIP OF TEWKSBURY, HUNTERDON  
COUNTY, NEW JERSEY DONATING CERTAIN PROPERTY TO THE  
TEWKSBURY FIRST AID AND RESCUE SQUAD**

**WHEREAS**, pursuant to N.J.S.A. 40A:12-13, a municipality may sell personal property not needed for public use, which sale may be in the form of a donation to a charitable organization providing emergency medical services to the community; and

**WHEREAS**, the Township of Tewksbury (the “Township”) owns certain personal property, including a 2002 Chevrolet Suburban bearing Vehicle Identification Number (VIN) 3GNGK26U42G226319 and a 2003 Ford E350 ambulance bearing VIN 1FDXE45F63HA62329 (collectively, the “Property”), which is currently in use by the Tewksbury First Aid and Rescue Squad for public safety purposes; and

**WHEREAS**, the Township Committee hereby finds and declares that the Property is no longer needed for public use; and

**WHEREAS**, the Township Committee desires to sell the Property to the Tewksbury First Aid and Rescue Squad, a nonprofit corporation of the State of New Jersey which provides emergency medical services in the Township of Tewksbury, County of Hunterdon, New Jersey, for its own use, which sale shall be for nominal consideration.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Tewksbury, Hunterdon County, New Jersey, as follows, that:

**SECTION 1.** The Township shall sell certain of its personal property identified as a 2002 Chevrolet Suburban bearing Vehicle Identification Number (VIN) 3GNGK26U42G226319 and a 2003 Ford E350 ambulance bearing VIN 1FDXE45F63HA62329 to the Tewksbury First Aid and Rescue Squad, a nonprofit corporation of the State of New Jersey which provides emergency medical services in the Township of Tewksbury, County of Hunterdon, New Jersey.

**SECTION 2.** The sale shall be for nominal consideration.


**SECTION 3.** All actions of the Township taken prior to the date of adoption hereof contemplated by this Ordinance are hereby ratified and approved.

**SECTION 4.** If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any remaining part thereof.

**SECTION 5.** All Ordinances or parts of Ordinances of the Township of Tewksbury heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 6.** This Ordinance shall take effect immediately upon its final passage, approval and publication as provided by law.
