Public Works Corner

Preparing Yard Waste for Pickup

It's that time of year again!
The Town provides routine yard waste collection for removal of leaves, branches, and other yard waste that you are unable to compost. Residents must use a paper lawn bag or another type of reusable container to place yard waste



out for collection, <u>yard waste in plastic bags will not be</u>
<u>accepted</u>. Below are some additional guidelines for disposing of yard waste:

- Do not mix yard debris with other bulk trash items
- Cut branches and twigs into lengths of 4' or less
- Branches and brush must be tied into bundles (tie with twine, or metal tie wires) or placed inside a container that can easily be emptied (containers must not weigh more than 80 pounds each). Bundles of branches cannot exceed 2' in diameter.
- Branches must be less than 3" in diameter (larger branches and tree trunks must be collected as bulky trash)

Yard Waste is collected on Mondays and Thursdays within the Town.

Slow Down, Move Over

As you may know, Maryland has a "Move Over" law. When an authorized emergency or maintenance vehicle is pulled over, all drivers must move



to another lane and/or slow down as we carefully pass. Unfortunately, the State is still experiencing deadly conditions on the side of the roads for those working to keep Marylanders moving safely. Our workers are out there every day helping motorists, and they are getting hit.

When you see our Public Works crews parked along the side of the road for maintenance or litter pick-up, please reduce speed, stay alert, and pass safely.

This project is

expected to last several weeks and will include the wired traffic signals being placed onto one diagonal overhead pole, the installation of pedestrian crosswalks, and pedestrian crossing countdown signals. The traffic signal will also be upgraded from a programed timed system to a live sensor-driven system to optimize traffic flow.

Please expect possible limited traffic delays and lane closures during this time period. This is a much-needed upgrade that the Town has been coordinating with SHA for the past few years.



April 4th, 1870 - April 4th, 2020

The Town of Upper Marlboro Government turned 150

While the area was settled around 1695, and the Upper Marlboro community was established in 1706, the formal governing body of the Town of Upper Marlboro was first incorporated on April 4, 1870 by Chapter 363 of the Acts of Maryland of 1870. The Act was passed by the State Senate on April 2nd, 1870; however, it was not official until being signed in law by Maryland Governor Oden-Bowie (name sound familiar?) on April 4th, 1870. Fun fact the Town shares its incorporation date with the City of Laurel.

Upper Marlboro Sustainable Communities Workgroup Update:

The Town of Upper Marlboro is Designated a Sustainable Community Again!

Evelyn Stephens, chair of the Town's Sustainable Communities Workgroup, announced at the virtual town meeting held on April 14, that the Maryland Department of Housing and Community Development has again awarded accreditation status to the Town of Upper Marlboro as a "sustainable community."

The state of Maryland passed a Sustainable Communities Act in 2010 with the goal of revitalizing and promoting reinvestment in Maryland's older communities. The Act also encourages economic growth and improvement in the designated Sustainable Community.

Since February 19, 2014, the Town of Upper Marlboro has been designated as a Sustainable Community. The designation allows the Town to apply for state funds that foster commercial revitalization and economic development.

Because of the designation of Sustainable Community, the Town has received funds under the auspices of the State of Maryland's Community Legacy Program, which have totaled \$150,000. The \$50,000 per fiscal year allowed the Town to create its Façade Improvement Program (FIP).

"We are thankful to business owners, MNCPPC, town staff and workgroup members who worked collaboratively to shepherd specific plans by applicants that foster business development and nourish the richness of Upper Marlboro as a community," said Mayor Linda Pennoyer.

Stephens noted other examples of sustainability supported by the Sustainable Communities Act: tree planting, walking trails, bike routes, recycling, home gardening, historic sites, flood controls and protecting natural and cultural assets.


Town of Upper Marlboro

The Town of Upper Marlboro is proud to announce that construction on Phase 1 of the Town's first community playground is set to begin in later summer/fall of 2020. This project is funded by both the Town and a grant from the Maryland Department of Natural Resources (DNR) Community

Parks & Playgrounds Program. This playground will be constructed on a vacant Town lot adjacent to the Town Hall & Police Department along Old Crain Highway. The theme of the playground pays tribute to the site's former use as a train depot as part of the Chesapeake Beach Railroad, which ran from Washington DC to Chesapeake Beach in Calvert County. This roadway had been defunct since 1935.

Phase One includes construction of the train depot play structure for ages 5-12, along with pathways and fencing Phase Two, slated for 2021, will consist of a train play structure for ages 2-5 years, and a green parking lot off Old Crain Highway. The playground will be accessible from the Sasscer Athletic fields and parking lot.





Code Enforcement

The Town of Upper Marlboro's
Code Enforcement Department
was formed in 2016 to guard
the health, safety and well-being of Town
residents through the enforcement of
property, building and environmental
regulations as set forth in the
ordinances of the Town of
Upper Marlboro and Prince
George's County, as well
as in state and federal
law. Code Enforcement

Officers survey the Town on a regular basis to ensure that community standards are met, and that Upper Marlboro remains a desirable place to live. Paramount to our mission is our goal of making Upper Marlboro a desirable place to live and work, as well as a memorable place for tourists to visit. The Department also assists the Police Department with parking enforcement, including the issuance of parking tickets and assisting with coin collection.

Below are a few key violations that the Code Officer Handles:

High Grass & Weeds: All exterior properties shall be properly maintained and no grass or weeds more than twelve (12) inches high.

Vehicle Storage: With the exception of being parked in a garage- abandoned, junked, wrecked, unregistered, untagged, or nonroad worthy vehicles are not permitted to be parked on private property.

Rental Properties: All rental properties within Town are required to be registered with Prince George's County. If you are a renter and unsure if the owner has a rental permit, contact Town Hall.

Property Identification: All properties shall have their street address installed to be plainly legible and visible from the street or road fronting the property.

Local Upper Marlboro Family Doctor Turns to Telemedicine

During this pandemic, many of us have been rethinking how we visit healthcare offices. Local Upper Marlboro Doctor Alain G. Champaloux and his staff would like you to know that they remain open and available to take care of all of your medical concerns, including referrals for COVID-19 testing. Dr. Champaloux is associated with MedStar Southern Maryland Hospital Center and has been located in downtown Upper Marlboro for more than 20 years.

For those who are reluctant or unable to come into a physical doctor's office during these times, Dr. Champaloux and his team of physicians are now offering telemedicine appointments. Telemedicine is the practice of caring for patients remotely when the provider and patient are not physically present with each other. Modern technology has enabled doctors to consult with patients by using HIPAA-compliant audio or video conferencing tools, such as smartphones. Telemedicine can also be done with a simple, old-fashioned, phone call.

Telemedicine technology allows the patient to stay safely in the comfort of their own home while speaking with a physician. This practice is being advocated by both the Centers for Disease Control (CDC) and World Health Organization (WHO), who state that telemedicine is an important tool in the fight against COVID-19 because it allows medical professions to monitor patients and reduce risks of them spreading the virus by traveling to hospitals.

"It makes me feel good when I am able to talk with my patients, listen to their concerns, and help them feel better," Dr. Champaloux said. "That's especially true now, when people are more worried than ever about their health, and they want to be seen by someone they trust.

"Even after all these years, interacting with my patients re-affirms my reasons for becoming a physician," he added.
