### The President's Message

Neighbors,

It has now been a little over one year since Commissioner Linda Pennoyer, Commissioner Wanda Leonard, and I were elected into office to serve as the Board of Town Commissioners for the Town of Upper Marlboro. Over the past year and a half, our administration has made great strides in improving the quality of life for residents and visitors, who live, work, learn and play in the historic Town of Upper Marlboro.

### **Town Financial Position**

As in any municipal government, the Town of Upper Marlboro manages an annual budget under the governance of the Board of Town Commissioners, the Town Treasurer, and the Director of Finance. A municipal budget is a financial instrument that weighs policy priorities against available public resources; specifies the ways and means of providing public programs and services; provides the government with a spending limitation; and provides transparency by which the government may be held accountable to at the end of each budget cycle.

### Fiscal Year (FY) 2018 Financial Update

Each year, municipalities are required by State law to undergo a robust financial audit, conducted by a third



party, to ensure proper financial controls are in place; accuracy of financial figures are being reported; identify and report fraud, waste and/or abuse and to provide general guidance on opportunities to improve the municipality's overall financial health. This month, the

- Largest expenditures were two capital projects - rehabilitation of the new Town Hall and Public Works facility improvements;
- More robust policies are needed around our financial oversight including the development of several more accounting policies;
- Town should have no more than 6-8 months operating revenue in savings accounts to ensure tax dollars are being maximized;
- Town should earmark funding for future projects to ensure proper planning and forecasting.

It should be noted that the Town Commissioners and I were elected midway through the FY 2018 budget, and yet still managed to end the Fiscal Year under budget.

## Fiscal Year (FY) 2019 Financial Update

My focus for Fiscal Year 2019 (July 1, 2018- June 30, 2019) has been to research and apply for external grant funding to help support our municipal operations. For decades the Town has solely relied on its tax base to fund Town services and operations and made little effort to pursue alternative funding available to municipalities.

It is important that the Town continue to provide excellent services to residents and continue to identify new and innovative ways to fund these services without relying solely on the residential tax base. In the last year, we have applied for over \$1.2 million in grants, which is the largest amount of external funding the Town

has ever applied for to date. These grants will provide funding for Public Safety upgrades and operations, new recreational opportunities, clean energy upgrades, infrastructure improvements, economic development, and streetscape improvements.

To date, the Town has been awarded over \$400,000 in funding for the upcoming Fiscal Year 2020 (the largest amount of non-tax base funding in its history). This includes a \$175,000 Bond Bill that we secured through the support of our 23B State Delegation representatives Senator Douglass J.J. Peters, Delegate Melvin Holmes, and Delegate Ron Watson. This Bond Bill funding will be used to rehabilitate a historic building located in the heart of downtown, which will be repurposed into the new Town of Upper Marlboro Welcome Center. We also received grant funds in the amount of \$200,000 dollars from the Maryland Department of Natural Resources to construct the Western Branch Waterway Park. This new recreational park will be equipped with a kayaking lift and fishing pier for residents to enjoy. The Town was also awarded a \$25,000 from the Maryland Department of Energy to fund energy efficient projects within the Towns corporate limits.

In addition to seeking grant funding, I have been working to identify other ways to generate new revenue streams outside of the residential tax base. Below are examples of several new alternative revenue streams:

- Food Truck Permitting Fees
- · Town Business Licensing
- Town Building and Construction Permitting

 Expanding Downtown parking availability and new competitive rates

### **Opportunities for Improvement**

Governing a municipality presents several seen and unforeseen challenges. The Town's biggest challenge has been increasing revenue generation, monitoring spending, while also meeting the needs of our community, and ensuring accurate forecasting across all areas of government. Prior to my election into office. previous administrations within the Town had done little work to ensure proper oversight and robust financial practices. For Fiscal Year 19, our biggest challenge was the overestimation of possible revenue from speed and red-light cameras that will not be obtained this fiscal vear due to several factors outside of the Town's control. In response to this change, in February of this year, we passed a revised mid-year budget which showed significant reductions in allocated funding in all Town departments (over \$400,000 in reductions were made across all departmental areas). Despite these reductions, there was still a financial gap that needed to be covered which we have been able to cover through our reserves. Even with these changes, to date the Town maintains over 8 months of operating funds in our reserve accounts. We will continue to refine our financial practices to improve our forecasting projections in preparation for FY 2020.

#### **Last Quarter (Fiscal Year 19) Forecast**

We anticipate closing out the year with over 6-8 months of Town

operating expenses in reserves, as recommended by our auditing firm. I am also working to grow the Town's tax base through annexation and continuing to identify external revenue sources such as additional grants, sponsorships, and public capitol funds.

My goal is to ensure that the Town remains financially secure and maintain the delicate balance between saving for the future and also ensuring we are maximizing our tax dollars to make much-needed improvements to our community.

## Town Infrastructure and Services

I take deep pride in the high-quality level of public services that the Town of Upper Marlboro provides to its residents and visitors.

### **General Government**

Our General Government branch is based out of our Town Hall offices and works to ensure that Town operations are functioning properly. To ensure that we are meeting high-quality standards in customer service, operations, finance, public safety, and public works. I have been working diligently with internal and external stakeholders to enhance our Town's internal business infrastructure. This includes upgrading our town IT systems, developing and implementing new business operational policy and procedures to improve our financial, human resource and administrative processes.

#### **Public Works & Beautification**

When I came into office, one of my main priorities was the beautification of our Town. For years, the Town has suffered from old signage, unkept landscaping, and trash & litter control issues. To address these issues, the Town has completed the below projects which have helped improve the overall look and feel of our community:

- Installation of additional trash & pet waste stations
- Town street sign replacement & rehabilitation
- Cahn Memorial beautification
- Old Crain Highway Monument restoration
- Installation of town welcome banners
- Overall landscaping of public land throughout Town

Through the efforts of our dedicated Public Works crews, the Town has worked to complete the above projects, as well as implementing robust litter collection and beautification initiatives, to bring the Town's appearance to the high standard our residents deserve.

#### **Public Safety**

After several external audits and studies, it became apparent to me that the Town's Police Department was not operating at an acceptable standard and was in fact, a liability to the Town. As a result, I made the unconventional decision to dismantle the entire force and rebuild the department from the ground up. This rebuilding has been extensive and has been done in partnership with the Prince George's County Police Department and the Prince Georges County Sherriff's Office. In January of this year, I was proud to announce that the Town of Upper Marlboro had hired its new Chief of

Police, Chief David Burse who retired from the Prince George's County Police department after 25 years of service. Since being hired, Chief Burse has been working diligently to build a police force that values transparency, professionalism, integrity, community-based policing and diversity.

### **Building Public/Private Relations**

To accomplish our goal of being the best place to live, work, learn and play in Prince George's County, it is key that we build relationships within our community stakeholders. This includes partnering with our residents, business leaders, elected officials at the County, State, and Federal level. In the last year, I have met with our Congressmen, State Delegation, Lieutenant Governor, County Council, and local Mayors. I have also encouraged our Town staff to also begin building their own networks with their staff counterparts at the County, State, and Federal levels as well. These partnerships have led to many benefits to the Town i.e. grant funding, increased advocacy, and legislative support.

### **Economic Development**

"A bustling downtown district filled with art and culture surrounding the thriving small businesses, shopping boutiques, and restaurants that string down Main Street. Historical attractions and sites are filled with visitors and residents, all looking to be engulfed by the Town's undeniable charm. Main Street is lined with matching lustrous black lampposts and carefully crafted visitor benches placed strategically along the historic red brick sidewalks."

This is our vision for the historic Town of Upper Marlboro, and over the past year, we have taken many strides to make this dream a reality. I have worked to create a business-friendly environment to spur economic development by engaging with Town business owners and passing new Town legislation to build a businessfriendly environment. The Town has also released a Request for Proposals to support the redevelopment of the Downtown area. We have also partnered with the Prince George's County Chamber of Commerce to stand up an Upper Marlboro Branch under the Prince Georges County Chamber of Commerce, the first of its kind in the region. The Upper Marlboro branch will be able to provide robust technical support to Upper Marlboro businesses, autonomy through its own Board of Directors and the ability to focus on the specific issues that impact the local Upper Marlboro business community.

### **Community Engagement & Events**

Over the past year, thanks to the assistance of our newly-formed volunteer Town Events Committee, the Town has organized and successfully executed over 14 community events. These community engagement opportunities are near and dear to me personally, because as a Mayor I am looking for new ways to foster and encourage an inclusive environment, while instilling a sense of community. These events have been attended by over 1,500 Town and Greater Upper Marlboro residents. Below are a few examples of successful events we have held to date:

I encourage all residents to come out and join us!

In closing, it's my duty as Mayor and President of the Board of Commissioners to oversee the infinite and untapped potential in the beautiful, historic Town of Upper Marlboro. I am thrilled to join forces with our local residents, businesses, County, State and Federal partners in making the Town a great place to live, work, learn, and play. My goal is to ensure that the Town of Upper Marlboro is a community that values inclusiveness, dedicated to public safety and champions economic growth and development. Through commitment, visionary leadership and hard work, the Town of Upper Marlboro is on a trajectory to becoming the premier destination for visitors and residents alike. As the year continues, I look forward to

### SCW: Why are you in this type of Business?


### **TUMHC Update**

### Schoolhouse Pond Stormwater Upgrade Project

#### **Clean Water Partnership Background**

Prince George's County, Department of the Environment, in alliance with the Clean Water Partnership (CWP) has been working on the planning and design of a stormwater quality improvement project near 14800 Governor Oden Bowie Drive, also known as Schoolhouse Pond.

#### **Project Details**

This project is being completed to meet regulatory requirements for treating stormwater within Prince George's County. The CWP program will install, upgrade, and maintain three forebays and an outfall. The forebays will capture excess sediment and other pollutants prior to releasing stormwater into the pond site, as well as provide better drainage to the outfall structure. Pedestrian access to the trail path will be restricted during construction. Construction is estimated to start in late Spring 2019 and will be complete by Winter 2019, weather permitting

The Clean Water Partnership is a Public-Private Partnership (P3) between Prince George's County and Corvias. The CWP is the first of its kind to design, build, finance, operate and maintain urban stormwater infrastructure to meet Municipal Separate Sewer System (MS4) regulatory requirements and is committed to retrofit up to 4,000 impervious acres. ## Spring Ahead Into Spring Cleaning!

In anticipation of the growing season, it is important to make sure your home is in tip top condition! Here's a few tips to consider as we transition to warmer temperatures.

"[Tip:] Inspect for loose or leaking gutters. Ensure that downspouts drain away from the foundation and are free of debris."

Keep in mind that Public Works has weekly bulk collection and twice per week lawn waste collection for all of your spring cleaning disposals.



#### CHECK OUTSIDE WATER SOURCES

### It is Tax Season- Don't Become A Victim

The IRS continues to warn consumers to guard against telephone scams from thieves intending to steal people's money or their identity. Criminals pose as the IRS to trick victims out of their money or personal information. Here are several tips shared by the IRS to help you avoid being a victim of these scams:

- Scammers make unsolicited calls. Thieves call taxpayers claiming to be IRS officials. They demand that the victim pay a bogus tax bill. They con the victim into sending cash, usually through a prepaid debit card or wire transfer. They may also leave "urgent" callback requests through phone "robo-calls," or phishing email.
- Callers try to scare their victims. Many phone scams
  use threats to intimidate and bully a victim into paying.
  They may even threaten to arrest, deport or revoke the
  license of their victim if they don't get the money.
- Scams use caller ID spoofing. Scammers often alter caller ID to make it look like the IRS or another agency is calling. The callers use IRS titles and fake badge numbers to appear legitimate. They may use the victim's name, address and other personal information to make the call sound official.
- Cons try new tricks all the time. Some schemes provide an actual IRS address where they tell the victim to mail a receipt for the payment they make. Others use emails that contain a fake IRS document with a phone number or an email address for a reply. These scams often use official IRS letterhead in emails or regular mail that they send to their victims. They try these ploys to make the ruse look official.
