New Real Property Assessments

Every year, on a rotating basis, the Maryland Department of Assessments and Taxation reassesses one third of the taxable real property in the State. This is our year so if you are a property owner in Town you should have received a property reassessment by now. This notice from the State is not a bill but rather the assessed value of the property used by the taxing authorities to apply the appropriate tax rate. Make sure to look it over since there is a time limit on when you can appeal the assessment. If you qualify for the Homestead Tax Credit, make sure that your property assessment reflects that fact.

The Town will not know the impact of the reassessments on the Town's tax revenues until next month. However, since the previous assessment in January 2008, statewide residential values of our reassessment group have decreased 22%, while commercial property values have declined 1%. Within our group in Prince George's County, residential values have declined 35% while commercial values have increased 0.7%.

New Addition to Town Hall

The current budget has some funds allocated for exploring the idea of building an addition to Town Hall. In order to start the discussion of what could be included in the new addition to Town Hall, I offer the following ideas based on my experience of working at Town Hall for the last three years.

- New Board Room to accommodate 100–150 people.
 To be designed as a multiple-purpose room that can be used for a variety of events and is also wired for broadcasting. The current Board Room has a rated capacity of only 50 people and was overcrowded at recent events. The current board room could then be used as office space for the Police Department
- <u>Locker Room</u> with bathroom and shower for Police Department, Public Works and Staff
- Break Room with small kitchen
- Storage Area(s)
- Small Conference Room
- Emergency Power

• <u>Connected to Town Hall</u> in a way that the current structure would be only for administrative offices.

A few citizens have expressed an interest in working on this project. In time, we will set up a formal committee. If you are interested in participating, please give us a call.

National Historic Register Nomination

We have forwarded to Park and Planning several questions raised by citizens and staff concerning the National Historic Register Nomination for part of the residential area of the Town. When we get a response, the Board will set up one or more public presentations. The time and date will be published in the *Landings* newsletter as well as the Town's website and letters will be sent to the properties included in the proposed District. If you have a preference that a meeting be scheduled for a weekend please let us know.

If the Board decides to sponsor the Nomination it will be sent to the County's Historic Preservation Commission for a public hearing. If approved, the nomination will then be forwarded to the State for review and then to the National Park Service.

Several people have expressed reservations about the Nomination because they were concerned that it would impose restrictions on what they could do with their property. I have reviewed the Federal regulations and found that the National Historic Register designation imposes no restrictions on the use of the property.
