- **This reservation only guarantees use of the field or court reserved.** All other park facilities (i.e. playground equipment, pavilion, etc.) are not solely for the use of the person(s) renting the field or court.
- The deposit will only be returned if the facilities are found to be in a clean condition after the reservation.
- Reservations are confirmed upon receipt of rental payment and deposit.
- Rental deposits will not be carried over from one year to the next.
- All reservations will be considered on a first-received basis and no more than one year in advance.
- Person must be 18 years of age or older to reserve the facilities.
- Person signing rental agreement for the facilities is responsible for all park rules.
- Facilities are rented on a “as is” basis. Park and pavilion areas are “open to the public” so condition is not guaranteed.
- Reservations may be canceled up to 14 days prior to reservation date, with return of rental fee and deposit less a \$10.00 administration fee.
- Rental fees will not be refunded due to inclement weather.
- Set up and clean up are the rental parties responsibilities. Clean up includes removal of all garbage. Rental parties agree to bring own trash bags to replace those in trash containers.
- Rental parties agree to follow all “General Park Rules”.

# Village of Vernon

## General Park Rules

Park Hours 6 am to 10 pm.

Pets must be on a leash. Owners are required to clean up after pets.

Motorized vehicles are permitted in parking area and roadways only.

Trash to be put in refuse containers.

Village is not responsible for the loss or damage of personal property.

Persons or organizations use of park facilities shall agree to hold the Village harmless from liability for incidents arising out of the persons or organizations use of the park.

The following activities and items are prohibited in the Village parks:

- Alcohol
- Fireworks
- Hunting or weapons
- Tree climbing
- Fires are restricted to picnic grills and for food preparation only
- Defacing park materials or property
- Use of motorcycles of all sizes, mopeds, go-carts, snowmobiles and golf carts are prohibited from park areas except for roadways designated for public travel.
- Speed limit 5 MPH

**Any exception of these rules and activities must have prior approval from the Village Council.**
