## Message from the Sheriff

2021 proved to be every bit as challenging as 2020 with the continuing issues of COVID-19 and the new laws enacted by the Washington state legislature. My Deputies and Administrative staff continued to adapt and managed to function at a high-level providing service to the citizens of Walla Walla County. This year I am optimistic that we will return to normal within the first quarter of 2022.

In addition to quarantines and isolation of various employees we had several deputies out on extended sick leave which proved to be a challenging scheduling endeavor. While we managed to maintain our normal levels of service we were operating at minimums for the majority of the year. While we have been struggling to fill open vacancies, we are excited to have five conditional offers out currently. These are all new hires and are awaiting spots at the Basic Law Enforcement Academy. We are losing a lot of experience, but I am confident our new hires will continue to uphold the vision, mission, and core values of the Walla Walla Sheriff's Office.

We have been delayed in accomplishing our goal of becoming accredited through the Washington Association of Sheriffs and Police Chiefs (WASPC), but I am confident that we will accomplish this in 2022 due to the hard work and diligence of the Walla Walla Sheriff's Office staff.

We continue to look to the future and how best to increase our staffing levels given the resources available. We will work with the county commissioners to develop innovative ways to most effectively use our citizens tax dollars to accomplish this goal. This annual report is designed to provide us and our citizens with an overview of the Walla Walla Sheriff's Office along with statistical information of what occurred in 2021. Remember, look at the data with a critical eye as it provides only one aspect of what is going on in our county and it will help us shape our strategy well into the future.

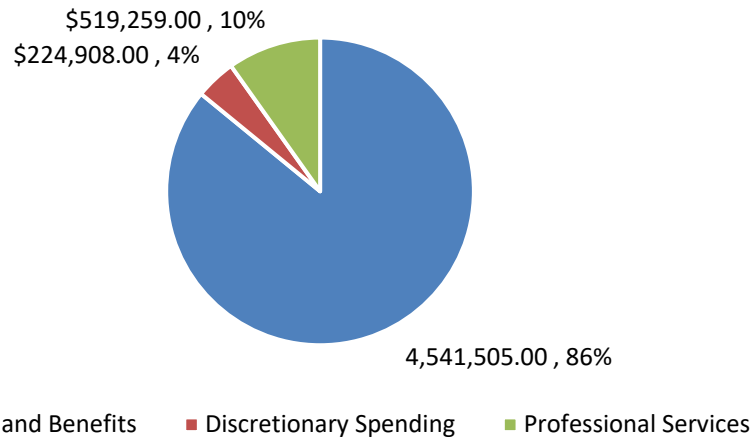

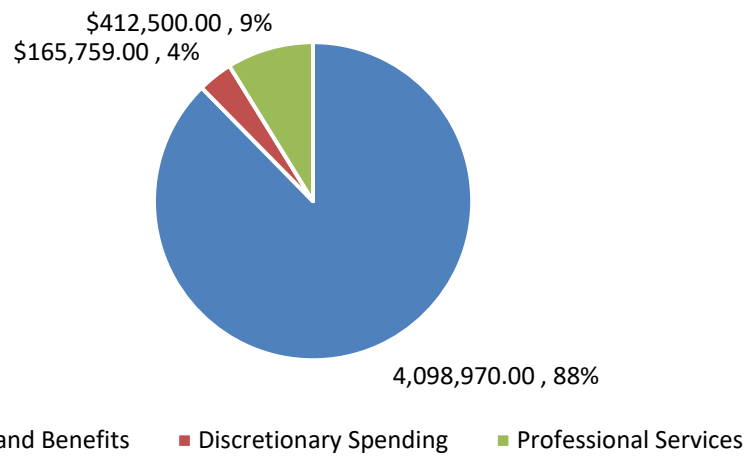

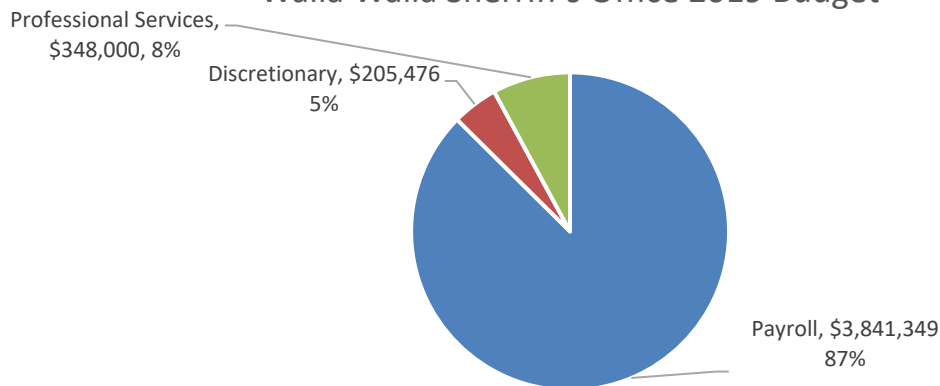
### Walla Walla Sheriff's Office 2021 Budget \$5,126,295

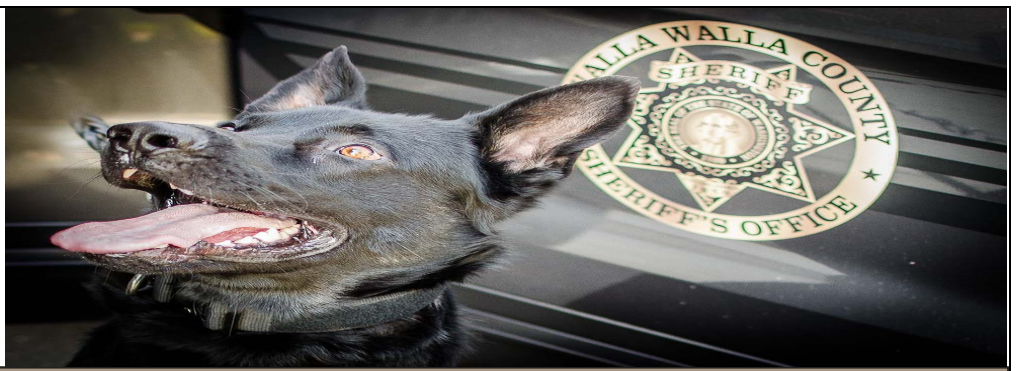

### **05/30/2021 - Spokane St. Walla Walla, WA**

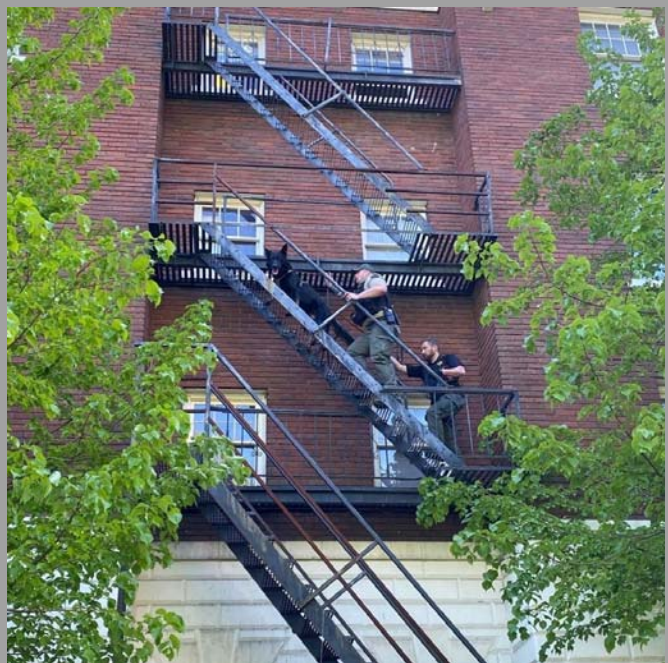
