# WALLA WALLA COUNTY PROPOSITION No. 1

#### **Emergency Communication Systems and Facilities Sales and Use Tax**

The Board of Walla Walla County Commissioners adopted Resolution No. 25-074, concerning a sales and use tax to fund emergency communications. If approved, this proposition would increase the sales and use tax within Walla Walla County by two-tenths of one percent (0.2%). As authorized and required by RCW 82.14.420, funds received from this tax must be used solely for the purpose of providing funds for costs associated with financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of emergency communication systems and facilities.

# EXPLANATORY STATEMENT WALLA WALLA COUNTY PROPOSITION NO. 1

### **Emergency Communication Systems and Facilities Sales and Use Tax**

Walla Walla County, the City of Walla Walla, the City of College Place and other entities have executed interlocal agreements to create Walla Walla Emergency Services Communication (WESCOM). WESCOM is currently funded primarily by user agency fees and seventy cent per-month excise taxes on each phone line. Property related to emergency communications is owned by Walla Walla County. WESCOM is staffed, operated and maintained by the City of Walla Walla.

Passage of Proposition No. 1 would authorize Walla Walla County to increase the sales and use tax rate by two-tenths of one percent (0.2%). This tax would be paid by anyone who makes a taxable purchase or use anywhere within the County. The new tax would be in addition to any sales taxes already authorized by law. Funds collected by this tax must be used solely for financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of emergency communication systems and facilities.

A vote of "Yes" would allow Walla Walla County to impose this additional tax for the funding of emergency communications systems and facilities. A vote of "No" would disallow this tax. If approved, the new tax would take effect on January 1, 2026.

When emergencies happen, reliable communication saves lives. This proposition invests in upgrading radio and dispatch systems to improve reliability and response times across Walla Walla County. It ensures that our first responders and dispatchers can communicate clearly, act quickly, and protect the public effectively.

We must also be prepared for major natural disasters. This proposition funds secure facilities and backup systems to keep emergency services running when disaster strikes. It also supports increasing staffing levels and investing in the training and retention of skilled emergency dispatchers—the calm, professional voices behind every 9-1-1 call.

Our current systems are aging and under strain. By establishing a sustainable, long-term funding source, this proposition protects local emergency services and builds resilient infrastructure that our community can count on, now and in the future.

At just two-tenths of one percent—20 cents on a \$100 purchase—this small investment delivers big returns in safety, speed, and reliability. Groceries and medical prescriptions are exempt from this sales tax. Support this critical step forward for Walla Walla County's public safety communications.

### **Registration Deadlines**

**July 28 -** Deadline for online and mail-in voter registrations, address changes, and other updates.

**July 28 - August 5 -** A person can register to vote or update their address in person at the Elections Office up until 8:00 p.m. on Election Day.

#### **Accessible Voting**

The Elections Office has an accessible voting unit (AVU) to assist with marking a ballot. Voters requiring reasonable accommodation or assistance may vote on the AVU in the Elections Office starting **July 18.**
