

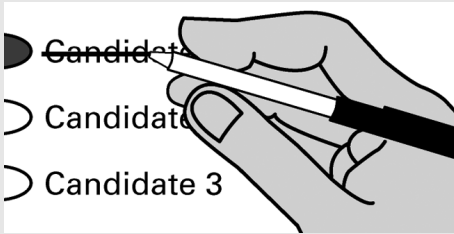

<p style="text-align: center;">PROPOSITION 1</p> <p style="text-align: center;">WALLA WALLA COUNTY FIRE PROTECTION DISTRICT NO. 5</p> <p style="text-align: center;">AUTHORIZATION FOR A 6-YEAR LEVY LID LIFT</p> <p>Walla Walla County Fire Protection District No. 5 Commissioners adopted Resolution No. 2023-2 concerning funding for fire protection and emergency medical services.</p> <p>This proposition would authorize an increase of the District's property tax levy rate to \$1.38 per \$1,000 assessed valuation for 2024 collection to fund District fire protection and emergency medical services, including maintenance, staffing, training, capital facilities, and equipment.
