WHEREAS, the Walla Walla County Board of Commissioners, as the county legislative authority, previously approved a Professional Services Agreement for calendar year 1997, with Addendums approved for calendar years 1998 through 2016, between Walla Walla County and Collection Bureau of Walla Walla, Inc., (formerly known as the Credit Bureau of Walla Walla, Inc.), one of the service agencies; and

WHEREAS, the Walla Walla County Board of Commissioners, as the County legislative authority, approved a Professional Service Bureau Contract for calendar year 2003 between Walla Walla County and Professional Service Bureau, Inc., one of the service agencies, and an Addendum for same has been approved for years 2004 through 2016; and

WHEREAS, Addendums to said Agreement and Contract extending same for 2017 have been submitted; and

WHEREAS, said Addendums have been reviewed and approved by the County Prosecuting Attorney and Judge Hedine; now therefore

BE IT RESOLVED by this Board of Walla Walla County Commissioners that they do hereby approve said Addendums for year 2017.


