

ORDINANCE NO. 37

A RESOLUTION RELATING TO THE OPERATION OF MOTOR VEHICLES ON ALL COUNTY ROADS AND STREETS IN THE COMMUNITY OF BURBANK, AND UNINCORPORATED AREA, AND IN THE COMMUNITY OF BURBANK HEIGHTS, AND UNINCORPORATED AREA, BOTH OF WALLA WALLA COUNTY, AND PROVIDING A PENALTY FOR VIOLATIONS THEREOF.

THE BOARD OF COUNTY COMMISSIONERS OF WALLA WALLA COUNTY DOES HEREBY RESOLVE:

Section 1. In order to make this resolution relating to the operation of motor vehicles on certain county roads in the vicinity of Burbank and Burbank Heights uniform with the provisions of the Washington Motor Vehicle Act (being Chapter 189 of the Laws of Washington for the year 1927) as amended or as hereafter may be amended; all of the provisions of the Washington Highway License Act (being Chapter 189 of the Laws of Washington for the year 1937) as amended or as they may hereafter be amended; and all of the provisions of the Washington State Highway Act (Being Chapter 53 of the Laws of Washington for the year 1937) as amended or as they hereafter may be amended; are hereby adopted by the County of Walla Walla and are by reference made a part of this resolution:

Section 2. Any person violating any of the terms of the laws referred to in section 1 of this resolution within the bounds to be hereafter mentioned shall be guilty of a violation of this resolution.

Section 3. It shall be unlawful for the operator of any vehicle to operate the same at a speed in excess of the following: thirty five (35) miles per hour as posted by the county engineer on any of the county roads hereafter mentioned:

All County Roads lying north of State Highway 3D and in Section 36, T9N, R30EWM and Sections 30 and 31, T9N, R31EWM in an unincorporated area known as Burbank Heights.

All County Roads and Streets in the unincorporated town of Burbank and in the vicinity thereof lying in Sections 1, 2, 11 and 12, T8N, R30EWM with the exception of County Road 869 beginning at the common section corner of sections 1, 2, 11 and 12, T8N, R30EWM and running easterly to State Highway 3 and North Ash Street beginning at a point on the north right of way line of Poplar Street and running northerly to State Highway 3.

Section 4. Any person who shall violate or fail to comply with any of the provisions of this resolution or who shall counsel, aid or abet any such violation or failure to comply shall be deemed guilty of a misdemeanor and shall be punished by a fine in any sum not exceeding \$100.00 or by imprisonment in the County Jail for a term not exceeding thirty (30) days, or by both such fine and imprisonment.

Section 5. If any of the proposed provisions of this resolution are held invalid or unconstitutional the remainder of the resolution shall not be affected thereby.

Section 6. This resolution is necessary for the immediate preservation of the public peace, health and safety, and shall be in effect immediately upon its passage.
