

ORDINANCE NO. 130

An Ordinance establishing rules and regulations for the use and operation of county garbage disposal and drop box sites pursuant to RCW 36.58.020.

Section 1: Disposal and drop box sites shall be used only by noncommercial collectors. Deposits shall be made only from cars and pickups or from trailers drawn thereby. Dumping from other vehicles is prohibited. Commercial collectors and trucks shall use designated and established dumps.

Section 2: The dumping of the following material is prohibited:

- (a) Trees, limbs, brush
- (b) Paper which is not boxed or in cartons
- (c) Dead animals
- (d) Explosives
- (e) Raw sewage
- (f) Burning materials

Section 3: At drop box sites all material shall be placed in furnished drop boxes only. In the event drop boxes are filled no dumping is permitted.

Section 4: Dumped material shall not be picked over or examined for salvage purposes without the prior written permission of the County Commissioners.

AMENDMENT NO. 1 TO
ORDINANCE NO. 130

An Ordinance amending Ordinance No. 130.

Section 1:

Section 1 of Ordinance No. 130 is amended to provide as follows:

"Disposal and drop box sites shall be used only by non-commercial collectors who are residents of Walla Walla County. Deposits shall be made only from cars and pickups or from trailers drawn thereby. Dumping from other vehicles is prohibited. Commercial collectors and trucks shall use designated and established dumps.

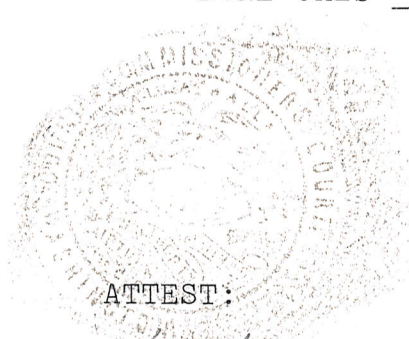
Section 2:

Section 2 of Ordinance No. 130 is amended to provide as follows:

"The dumping of the following material is prohibited:

- (a) Trees, limbs, brush
- (b) Paper which is not boxed or in cartons
- (c) Dead animals
- (d) Explosives
- (e) Raw sewage
- (f) Burning materials
- (g) Waste building materials or demolition debris
