

A RESOLUTION RELATING TO THE OPERATION OF MOTOR VEHICLES ON 10 roads in the Gardena Area IN WALLA WALLA COUNTY, WASHINGTON, AND PROVIDING A PENALTY FOR VIOLATION THEREOF.

THE BOARD OF COUNTY COMMISSIONERS OF WALLA WALLA COUNTY, STATE OF WASHINGTON, DO HEREBY RESOLVE:

Section 1 In order to make this Resolution, relating to the operation of motor vehicles, on a certain County Road, known as 10 Roads in the Gardena Area, in Walla Walla County, Washington, uniform with the provisions of the Washington Motor Vehicle Act (Being Chapter 309 of the Laws of Washington for the year 1927) as amended or as hereafter may be amended; all of the provisions of the Washington Highway License Act (Being Chapter 189 of the Laws of Washington for the year 1937) as amended or as they may hereafter be amended; and all of the provisions of the Washington State Highway Act (Being Chapter 53 of the Laws of Washington for the year 1937) as amended or as they hereafter may be amended; are hereby adopted by the County of Walla Walla and are by reference made a part of this resolution.

Section 2 Any person violating any terms of the laws referred to in Section 1 of this Resolution within the bounds to be hereafter mentioned shall be guilty of a violation of this Resolution.

Section 3 It shall be unlawful for the operator of any vehicle to operate the same at a speed in excess of the following: 20 (Twenty) miles per hour on any street or road specifically mentioned in the following description or any speed posted by the County Engineer on any street or road in the following description, during the months of June and July between the hours of 8:00 a.m. and 8:00 p.m. daily:

- 1.. Byrnes Road, from Road 1670, westerly three-fourths of a mile (County Road Log No. 1707, from milepost 1.03 to 1.78) in Section 31 and 32 of T 7 N, R 33 EWM and Section 5 of T 6 N, R 33 EWM, and
- 2.. Touchet-Gardena Road, from the Walla Walla River to the Munns Road (County Road Log No. 9319, from Milepost 0.98 to 1.58) in Section 3 of T 6 N, R 33 EWM, and
- 3.. Gardena Creek Road, from Small Creek to Road 3297 (County Road Log No. 3282, from Milepost 0.34 to 0.74) in Section 9 of T 6 N, R 33 EWM, and
- 4.. Gardena Creek Road, from Road 3307 to Road 3307 (County Road Log No. 3282, from Milepost 1.27 to 2.21) in Section 10 and 15 of T 6 N, R 33 EWM, and
- 5.. Gardena-Lowden Road, from Road 3363 to Road 3285 (County Road Log No. 9319, from Milepost 2.97 to 3.58) in Section 11 of T 6 N, R 33 EWM, and
- 6.. Road No. 3285, From a point about one-half mile south of Road 9319 to a point approximately one-tenth of a mile south of Road 9319 (County Road Log No. 3285, from Milepost 1.57 to 2.00) in Sections 11, 12, 13, and 14, of T 6 N, R 33 EWM, and
- 7.. Gardena-Lowden Road, from a point one-tenth of a mile Westerly of Road 9310 to Pine Creek (County Road Log No. 9319, from Milepost 5.00 to 5.36) in Section 7 of T 6 N, R 34 EWM, and
- 8.. Road No. 3394, from Road 9319 to Road 9310 (County Road Log No. 3394, from Milepost 0.00 to 0.05) in Section 7 of T 6 N, R 34 EWM, and
- 9.. Road No. 9310, from Road 9319 to Stateline Road (County Road Log No. 9310, from Milepost 0.00 to 0.59) in Sections 7 and 18 of T 6 N, R 34 EWM, and
- 10.. Gardena-Lowden Road, from the Burlingame Ditch to Road 3399 (County Road Log No. 9319, from Milepost 6.84 to 8.04) in Sections 5 and 8 of T 6 N, R 34 EWM, and Section 32 of T 7 N, R 34 EWM.


Section 4 Any person who shall violate or fail to comply with any of the provisions of this Resolution, or who shall counsel, aid, or abet any such violation or fail to comply shall be deemed guilty of a misdemeanor and shall be punished by a fine in any sum not exceeding \$ 250.00.

Section 5 If any of the proposed provisions of this Resolution are held invalid or unconstitutional, the remainder of the Resolution shall not be affected thereby.

Section 6 This Resolution is necessary for the immediate preservation of the public peace, health, and safety, and shall be in effect immediately upon its passage.
