Mill Creek Road (County Road Log No. 97330) from mile post 8.89 to milepost 13.04, situate in Sections 22, 23, 26 and 35, 1.7N, 1.37E, WM and Sections 1, 2 and 12, 1.6N, 1.37E, WM.

BE IT HEREBY ORDAINED THAT SUBSECTION 10.04.357 is added to the WALLA WALLA COUNTY CODE and reads as follows:

10.04.357 Ayer Road and Foster Road.

- A. It is unlawful for the operator of any vehicle to operate the same at a speed in excess of thirty-five miles per hour on any street or road specifically mentioned in the following description:
 - 1. Ayer Road (County Road Log No. 93650) from milepost 24.70 to milepost 25.70, situate in Sections 21, 28 and 29, T.11N., R.35E., WM; and
 - 2. Foster Road (County Road Log No. 97070) from milepost 1.99 to milepost 2.91, situate in Sections 5 and 6, T.6N., R.37E., WM and Sections 31 and 32, T.7N., R.37E., WM.
- B. If any of the provisions of this section are held invalid or unconstitutional, the remainder of the section shall not be affected thereby. (November 12, 1985)
