

ORDINANCE NO. 184

AN ORDINANCE REGULATING THE OPERATION OF VEHICLES ON MILL CREEK ROAD
WITHIN THE UNINCORPORATED AREAS OF WALLA WALLA COUNTY, WASHINGTON.

WHEREAS, there is a need to regulate the operation of vehicles on Mill
Creek Road for the immediate preservation of the public peace, health and
safety; and,

WHEREAS, a public hearing was held on November 12, 1985, at 2:00 P.M. to
take public testimony in favor of and in opposition to said regulation; now
therefore,

BE IT HEREBY ORDAINED that subsection 10.04.381 is added to the WALLA
WALLA COUNTY CODE and reads as follows and subsections 10.04.290 and 10.04.380
are hereby repealed:

10.04.381 Mill Creek Road.

- A. It is unlawful for the operator of any vehicle to operate the same at a
speed in excess of forty miles per hour on any street or road specifically
mentioned in the following description:

Mill Creek Road (County Road Log No. 97330) from mile post 8.14 to
milepost 14.32, situate in Sections 22, 23, 26 and 35, T.7N., R.37E., WM
and Sections 1, 2 and 12, T.6N., R.37E., WM.

- B. If any of the provisions of this section are held invalid or unconstitu-
tional, the remainder of the section shall not be affected thereby.
(November 12, 1985)

and Sections 1, 2 and 12, T.6N., R.37E., WM.


- B. If any of the provisions of this section are held invalid or unconstitu-


