

ORDINANCE NO. 185

AN ORDINANCE REGULATING THE OPERATION OF VEHICLES ON ALL COUNTY ROADS WITHIN A CERTAIN DESCRIBED AREA IN THE UNINCORPORATED AREA OF WALLA WALLA COUNTY, WASHINGTON

WHEREAS, there is a need to regulate the operation of vehicles on all roads within an area described below for the immediate preservation of the public peace, health and safety; and,

WHEREAS, a public hearing was held on November 12, 1985, at 2:00 P.M. to take public testimony in favor of and in opposition to said regulation; now therefore,

BE IT HEREBY ORDAINED that subsection 10.04.320 to the WALLA WALLA COUNTY CODE be amended to include the following described area:

All County Roads and streets within an area bounded by a line beginning at the northeast corner of Section 4, T.6N., R.36E., WM; thence southerly, along the east line of said Section 4, to the southeast corner thereof; Thence westerly, along the south line of Sections 4, 5 and 6, said Township and Range, to the west right of way line of Braden Road (County Road Log No. 50930); Thence northerly, along said west right of way line, to the northwesterly right of way line of the Lower Milton Road (County Road Log No. 92570); Thence northeasterly along said northwesterly right of way line, to the west line of Section 5, said Township and Range; Thence northerly, along said west line, to the south line of the north one half of the north one half of said Section 5 and the terminus of this description; and,

- B. If any of the provisions of this section are held invalid or unconstitutional, the remainder of the section shall not be affected thereby. (November 12, 1985)
