ORDINANCE NO. 186

AN ORDINANCE AMENDING ORDINANCE 44 - WALLA WALLA COUNTY CODE - CHAPTER 8.12 - PERTAINING TO SEPTIC TANK CLEANING REGULATIONS

BE IT ORDAINED by the Board of Walla Walla County Commissioners of Walla Walla County, Washington:

- 1. Sections 8.12.020, 8.12.030 are amended as follows:
- 8.12.020 Permit--Required. It is unlawful for any person, firm or corporation to clean any septic tank, sewage pit or other means of sewage disposal without first having obtained a registration permit from the Walla Walla County-City Health Department. Permits so issued are renewable January 1st of each year and are not transferable.
- 8.12.030 Permit--Bond Requirements. All applicants shall deliver to the Walla Walla County-City Health Department, before receiving the registration permit, a bond to the County of Walla Walla in a form approved by the County Health Officer in the sum of one thousand dollars or a cash deposit in the amount of one thousand dollars in a form approved by the County Health Officer, guaranteeing the faithful performance of all work undertaken to be done under the provisions of the registration permit. Any person who may be damaged by the wrongful acts of the registrant or by his failure to perform any of the work agreed to be done under the terms of this chapter, shall, in addition to other legal remedies, have the right of action in his own name on such bond or cash deposit for all damages.
- 2. Section 8.12.040 is hereby renumbered 8.12.060, and is amended as follows:
- 8.12.060 Permit Suspension & Revocation. The registration permit may be revoked or suspended by the County Health Officer for failure of the registrant to comply with the provisions of this chapter and any and all other regulations pertaining to the disposal of sewage pumpings. Any person feeling aggrieved because of the permit suspension or revocation may appeal to the Walla Walla County Board of Health.
- 3. Section 8.12.050 is renumbered to 8.12.070 and is amended as follows:

- 8.12.070 Violaton--Penalty. Anyone violating or failing to comply with the provisions of this chapter shall be deemed guilty of a misdemeanor and upon conviction thereof shall be subject to a fine of not more than three hundred dollars (\$300.00) or to imprisonment of not more than ninety (90) days or by both such fine and imprisonment. Each day a violation of this chapter continues shall be considered a separate offense.
- 4. There is hereby added to the Walla Walla County Code 8.12.040 which will read as follows:
- 8.12.040 Equipment. Vehicles used with pumping equipment attached must comply with all requirements applicable to commercial vehicles. Tanks shall be fully enclosed, strong enough for all conditions of operation, be leakproof, fly proof and operate to prevent spillage at all times. Equipment must be maintained so as not be be offensive or create a potential health hazard. All vehicles used in these operations shall carry in a conspicuous place the name of the firm or operator under which the business is conducted. Each vehicle permitted to operate under this chapter shall display in a conspicuous place on both sides of the vehicle the sign, REGISTERED BY THE WALLA WALLA COUNTY-CITY HEALTH DEPARTMENT. The lettering shall be in plain letters at least two inches high. The Health Officer is authorized to conduct inspections of equipment to determine compliance with this chapter.
- 5. There is hereby added to the Walla Walla County 8.12.050 which will read as follows:
- 8.12.050 Method if Disposal & Records. Operators shall keep records showing the name and address of the customer, date pumped, person doing the pumping job and where disposal is made. These records shall be made available to the Health Officer upon request.

If sewage pumpings are disposesd of in Walla Walla County, disposal must be at an approved municipal or community sewage treatment plant or lagoon, but only with prior approval of the sewage system operator. Sewage pumpers are required to pay all fees associated with disposal at a treatment plant or lagoon. Sewage pumpings may be disposed of on the property from which they originate, provided that prior approval is received by the Health Officer on a case-by-cases basis.

If sewage pumpings from Walla Walla County are disposed of out of county, the disposal site must be approved by the jurisdictional health agency.
