WHEREAS, a public hearing was held on October 15, 1990, at 2:00 P.M., to take testimony in favor of and in opposition to said regulation; now therefore,

BE IT HEREBY ORDAINED, by the Board of County Commissioners of Walla Walla County, that a new Chapter be added to Title 9 of the Walla Walla County Code which shall contain the following:

Chapter 9.08 SHOOTING OF FIREARMS FROM OR NEAR COUNTY ROADS

Section 9.08.010. A person is guilty of the crime of shooting a firearm from or near a county road if that person shoots a firearm from, across or along the maintained portion of any county road or within one hundred feet of the centerline of the improved portion of Pedigo Road or Russell Siding Road.

Section 9.08.020. That any person who violates the foregoing section shall be guilty of a misdemeanor, punishable by not more than 30 days in the county jail, or a fine of \$300.00 or both.

Section 9.08.030. That while on duty within their respective jurisdiction, law enforcement officers are exempt from the foregoing sections.
