

**AN AMENDMENT TO ORDINANCE NUMBER 158, REGULATING THE OPERATION OF  
MOTOR VEHICLES ON FISHHOOK PARK ROAD IN THE UNINCORPORATED AREA OF  
WALLA WALLA COUNTY, WASHINGTON**

**WHEREAS**, an Ordinance relating to the operation of motor vehicles on Fishhook Park Road (County Road Log No. 40310), Walla Walla County, Washington, was adopted by the Board of County Commissioners on July 1, 1980, setting a speed limit of thirty-five miles per hour on said road from milepost 2.33, as measured from State Route 124, thence westerly to milepost 4.18 and end of said County Road; and,

**WHEREAS**, there is a need to regulate the speed of vehicles on an additional segment of said road for the preservation of the public peace, health, safety, and welfare; and,

**WHEREAS**, a public hearing was held on August 23, 1993, at 2:00 P.M., for the purpose of hearing testimony in favor of and/or in opposition to said additional regulation; now therefore,

**BE IT HEREBY ORDAINED**, by this Board of County Commissioners, that subsection 10.04.370 of the Walla Walla County Code be amended to include the following description:

Fishhook Park Road (County Road Log No. 40310)  
from milepost 0.750, as measured from SR 124,  
to milepost 2.33, situate in Sections 29, 30,  
31, and 32, Township 10 North, Range 33 East,  
W.M., Walla Walla County, Washington.

AMENDING SUBSECTION 10.04.370 TO THE WALLA WALLA COUNTY CODE

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Walla Walla County, Washington, will hold a public hearing at 2:00 P.M., Monday, August 23, 1993, in the Commissioners' Chambers, County Courthouse, 315 W. Main Street, Walla Walla, Washington, to hear testimony in favor of and/or in opposition to amending subsection Chapter 10.04.370 of the Walla Walla County Code.

WHEREAS, there may be a need to reduce the speed limit of vehicles on the following described road from 50 miles per hour to 35 miles per hour for the preservation of the public peace, health, safety, and welfare:

Said subsection shall be amended to include the following described road segment:

Fishhook Park Road (County Road Log No. 40310) from milepost 0.750, as measured from SR 124, to milepost 2.33, situate in Sections 29, 30, 31, and 32, Township 10 North, Range 33 East, W.M., Walla Walla County, Washington.
