

ORDINANCE NO. 223

AN ORDINANCE REGULATING THE OPERATION OF MOTOR VEHICLES ON SOUTH WILBUR AVENUE IN THE UNINCORPORATED AREA OF WALLA WALLA COUNTY, WASHINGTON

WHEREAS, there is a need to regulate the operation of vehicles on the following described road for the preservation of the public peace, health, safety, and welfare; and,

WHEREAS, a public hearing was held on June 6, 1994, at 2:00 P.M., to take testimony in favor of and/or in opposition to said regulation; now therefore,

BE IT HEREBY ORDAINED by the Board of County Commissioners of Walla Walla County, Washington, that subsection 10.04.146 be added to the Walla Walla County Code which shall contain the following:

10.04.146 SOUTH WILBUR AVENUE

- A. It is unlawful for the operator of any motor vehicle to operate the same at a speed in excess of twenty-five (25) miles per hour on any street or road specifically mentioned in the following description:

South Wilbur Avenue (County Road Log Number 57200) from Reser Road (MP 0.450) to Shelton Road (MP 0.950) situate in Sections 33 and 34, Township 7 North, Range 36 East, W.M.

- B. If any of the proposed provisions of this section are held invalid or unconstitutional, the remainder of the section shall no be affected thereby.
