BE IT HEREBY ORDAINED by the Board of County Commissioners of Walla Walla County, Washington, that subsections 10.04.221 and 10.04.301 be added to the Walla Walla County Code which shall contain the following respectively:

10.04.221 HIGHLAND ROAD

A. It is unlawful for the operator of any motor vehicle to operate the same at a speed in excess of twenty five (25) miles per hour on any street or road specifically mentioned in the following description:

Highland Road (County Road Log Number 51600) from MP 0.380 to the Walla Walla City Limits at MP 0.684, situate in Section 31, Township 7 North, Range 36 East, W.M.

B. If any of the proposed provisions of this section are held invalid or unconstitutional, the remainder of the section shall no be affected thereby.

AND,

10.04.301 HIGHLAND ROAD

A. It is unlawful for the operator of any motor vehicle to operate the same at a speed in excess of thirty (30) miles per hour on any street or road specifically mentioned in the following description:

Highland Road (County Road Log Number 51600) from Justice Avenue at MP 0.000 to MP 0.380, situate in Section 31, Township 7 North, Range 36 East, W.M.

B. If any of the proposed provisions of this section are held invalid or unconstitutional,

the remainder of the section shall no be affected thereby.

BE IT FURTHER RESOLVED that subsections 10.04.221 and 10.04.301 be added to the Walla Walla County Code, subject to the signing of the applicable Ordinance.
