ORDINANCE NO. 248

AN AMENDMENT HAS BEEN REQUESTED TO THE CITY OF COLLEGE PLACE COMPREHENSIVE PLAN FROM EXCLUSIVE AGRICULTURE TO PUBLIC RESERVE ON PROPERTY LOCATED NORTHEAST OF THE CITY OF COLLEGE PLACE SEWAGE TREATMENT PLANT OFF OF OWENS ROAD, WEST OF COLLEGE PLACE, and

WHEREAS, the Planning Commission held a public hearing on February 3, 1999 to consider the request and recommends to the Board of County Commissioners that the Comprehensive Plan Amendment request be approved based on the following findings:

1. At the time of adoption of the UGA and development of the Urban Area Comprehensive Plan, the City of College Place did not anticipate further expansion of the treatment plant as proposed.
2. There is a public need for the amendments.
3. The facility cannot be accommodated within the existing UGA, and
