ORDINANCE NO. 256

WHEREAS, Walla Walla County adopted Walla Walla County Code, Chapter 15.04 in regards to Air Pollution Control and Open and Agricultural Burning, and

WHEREAS, the cost to the County for providing burn control and permitting has increased, and

WHEREAS, the County desires to maintain local control over the agricultural burning permitting process, and

WHEREAS, the County has the statutory authority to increase the local fee for agricultural burning to \$1.25/acre, now therefore

BE IT RESOLVED, by the Board of Walla Walla County Commissioners that they amend Section 15.04.142, Walla Walla County Code to state: "The annual fee for Agricultural burning on areas of ten acres or more shall be \$20, plus \$.25/acre for county administration . . .".
