ORDINANCE NO. 260

AN ORDINANCE REGULATING THE OPERATION OF MOTOR VEHICLES ON ALL COUNTY ROADS WITHIN A CERTAIN DESCRIBED AREA IN THE UNINCORPORATED AREA OF WALLA WALLA COUNTY, WASHINGTON

WHEREAS, there is a need to regulate the operation of vehicles on all roads within an area described below for the immediate preservation of the public peace, health and safety; and,

WHEREAS, a public hearing was held on February 26, 2001, at 2:00 P.M. to take public testimony in favor of and in opposition to said regulation; now therefore,

BE IT HEREBY ORDAINED that subsection 10.04.320 to the Walla Walla County Code be amended to include the following described area:

- A. That portion of Power Line Road extending from the south line of Section 4, Township 6 North, Range 36 East, W.M. to mile post 1.231 being just south of Cameron Bridge; and,
- B. If any of the provisions of this section are held invalid or unconstitutional, the remainder of the section shall not be affected thereby.
