WALLA WALLA COUNTY ORDINANCE NO. 280

BE IT HEREBY ORDAINED that effective January 1, 2003 Walla Walla County Code, Chapter 15.04 ("Uniform Fire Code and Uniform Fire Code Standards") and County Ordinance No. 273 are hereby amended as follows:

15.04.142 - Agricultural Burn - Permit Fees

- A) The fee for agricultural burning on areas of one-half ( $\frac{1}{2}$ ) acre or more shall be \$2.00 per acre. Of this amount, \$.25 per acre shall be allocated to the County for program administration, \$1.00 per acre shall be allocated to the Walla Walla County Conservation District for permit issuance, and \$.75 per acre shall be remitted to the Washington State Department of Ecology.
