ORDINANCE NO. 284 AN ORDINANCE ADOPTING AMENDMENTS TO THE WALLA WALLA URBAN AREA COMPREHENSIVE PLAN 1996-2015

WHEREAS, the Walla Walla County Planning Commission held a public hearing on March 5, 2003 to consider a request by the City of Walla Walla to approve the adoption of proposed amendments to the Walla Walla Urban Area Comprehensive Plan 1996-2015 (Docket Number UGA 02-02); and

WHEREAS, every county planning under the Growth Management Act (GMA) must adopt a comprehensive plan, containing the required elements, for their jurisdiction. The Act provides that countries must phase the development of the comprehensive plans. Comprehensive Plan amendments may be adopted one time per year. The amendments here are a part of the regularly scheduled annual update.

WHEREAS, RCW 36.70A (GMA) requires that a plan address the following:

- The planning goals contained in the Act.
- Compliance with the County-wide Planning Policies.
- Mandatory elements, including the Urban Growth Area (UGA)
- Consistency between jurisdictions

WHEREAS, the following findings apply;

- A. The State Department of Community, Trade and Economic (CTED) along with other affected agencies, has reviewed and approved the City's Comprehensive Plan. The map amendments do not appear to substantially change the orientation of the original document.
- B. The County was originally a partner in the development of the Urban Area Plan, and is supportive of amendments that serve to update, personalize, and modify this document in a manner that better serves the community.
- C. The proposal conforms to the UGA requirements as contained in the GMA and as evidenced by the adoption of the UGA boundary by the County.
- D. There has been public involvement, which ensures that those individuals who are affected by this decision have an opportunity to be involved in the process.
- E. These changes are small in scope and do not affect the buildable lands inventory in a sufficient manner.

WHEREAS, no conditions were recommended; and

WHEREAS, pursuant to its Resolution No. 03-10, the Planning Commission recommends that the Board of County Commissioners approve the request by the City of Walla Walla.



Now therefore,

BE IT RESOLVED, by the Walla Walla County Board of Commissioners that they approve the request for adoption of amendments to the Walla Walla Urban Area Comprehensive Plan 1996-2015, Docket Number UGA 02-02, based on the information and findings above.
