**WHEREAS**, an amended ordinance has been submitted to the Board of Walla Walla County Commissioners, acting as the Walla Walla County Board of Health, for consideration and adoption; and

**WHEREAS**, a properly advertised public hearing was held on Monday, November 3, 2003 to hear testimony in favor of or in opposition to the adoption of said ordinance; now therefore

**BE IT HEREBY RESOLVED** by this Board of Walla Walla County Commissioners that said ordinance shall be adopted.

**BE IT FURTHER RESOLVED** that said ordinance shall go into effect January 1, 2004.

AN ORDINANCE AMENDING ORDINANCE NO. 192 AND AMENDING WALLA WALLA COUNTY CODE - CHAPTER 8.08.050 - PROVIDING FOR THE ADOPTION BY REFERENCE OF CHAPTER 173-351 WAC - "CRITERIA FOR MUNICIPAL SOLID WASTE LANDFILLS", CHAPTER 173-350 WAC - "SOLID WASTE HANDLING STANDARDS" AND CHAPTER 173-304 WAC - "MINIMUM FUNCTIONAL STANDARDS FOR SOLID WASTE HANDLING", AS THE SAME MAY NOW EXIST OR HEREAFTER BE AMENDED.

BE IT ORDAINED by the Board of Walla Walla County Commissioners acting as the County Board of Health that:


(1.) Section 8.08.050 of the Walla Walla County Code is amended as follows:

8.08.050 Adoption of Criteria for Municipal Solid Waste Landfills, Solid Waste Handling Standards and Minimum Functional Standards for Solid Waste Handling. The Criteria for Municipal Solid Waste Landfills, Chapter 173-351 WAC, the Solid Waste Handling Standards, Chapter 173-350 WAC and the Minimum Functional Standards for Solid Waste Handling, Chapter 173-304 WAC are hereby adopted by reference as the solid waste handling code of Walla Walla County as the same may now exist or hereafter be amended. All amendments and additions to the Criteria for Municipal Solid Waste Landfills, the Solid Waste Handling Standards and the Minimum Functional Standards for Solid Waste Handling when printed and filed with the County Auditor shall become amendments and additions to this chapter.


