ORDINANCE NO. 291

APPROVING A REQUEST BY WALLA WALLA COUNTY FOR A ZONING CODE TEXT AMENDMENT TO WALLA WALLA COUNTY CODE CHAPTER 18.10 RELATIVE TO FLOOD DAMAGE PREVENTION, TO COMPLY WITH REQUIREMENTS OF THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) AND THE NATIONAL FLOOD INSURANCE **PROGRAM**

WHEREAS, application has been made by Walla Walla County Community Development Department to request a Zoning Code Text Amendment for Flood Damage Prevention, and

WHEREAS, the Planning Commission held a public hearing on December 3, 2003 to consider the request and recommends to the Board of County Commissioners that the Zoning Code Text Amendment be approved based on the following findings:

The Environmental Review Committee (ERC) has issued a Determination of Non-Significance (DNS) on the proposal. The ERC has assessed the proposed amendment and has determined that the proposed amendment will benefit the public health, safety and Welfare by the implementation of provisions designed to: Protect human life and health; minimize the need for rescue and relief efforts associated with flooding and generally undertaken at the expense of the general public and minimize prolonged business interruptions.

This proposed amendment is a public necessity to be in compliant with the requirements of Federal Emergency Management Agency (FEMA) and maintain good standing in the National Flood Insurance Program.

The approval of this proposed amendment will constitute good zoning and planning by: Minimize expenditure of public money and costly flood control projects; To minimize damage to public facilities and utilities such as water and gas mains, electric, telephone and sewer lines, streets and bridges located in areas of special flood hazard and To help maintain a stable tax base by providing for the sound use and development of areas of special flood hazard so as to minimize future flood blight areas.

This proposal fulfills the following policies of the Walla Walla County Comprehensive Plan 2001-2021: Policy CA-11: Continue to utilize Walla Walla County regulations adopted in accordance with Federal Emergency Management Agency standards to designate and regulate frequently flooded areas. Policy CA-14: Adopt the code amendments recommended in the Comprehensive Flood Hazard Management Plan.
