**ORDINANCE NO. 361**

**ADJUSTING WALLA WALLA COUNTY'S BUILDING PERMIT FEES FOR  
POLE BUILDINGS AND AMENDING TABLE 9-A OF ORDINANCE 346.**

**WHEREAS**, the County enacted Ordinance 346 in July of 2007; and

**WHEREAS**, Table 9-A, of Ordinance 346 set forth fees for various building permits;  
and

**WHEREAS**, the County has noted that the square-foot valuation for pole buildings is not  
up-to-date; and

**WHEREAS**, the Department of Community Development has proposed that the square-  
foot valuation be adjusted to better reflect market conditions; and

**WHEREAS**, a public hearing was held on February 11, 2008 on the proposed valuation  
change; and

**WHEREAS**, the Board of County Commissioners finds that the proposed adjustment is  
in the public interest;

**NOW THEREFORE**,

**BE IT ORDAINED**, by the Walla Walla County Board of County Commissioners that  
they ordain as follows:

**Section 1. Amendment to Table 9-A of Ordinance 346:**
