ENVIRONMENTAL CHECKLIST

Purpose of checklist:

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. An environmental impact statement (EIS) must be prepared for all proposals with probable significant adverse impacts on the quality of the environment. The purpose of this checklist is to provide information to help you and the agency identify impacts from your proposal (and to reduce or avoid impacts from the proposal, if it can be done) and to help the agency decide whether an EIS is required.

Instructions for applicants:

This environmental checklist asks you to describe some basic information about your proposal. Governmental agencies use this checklist to determine whether the environmental impacts of your proposal are significant, requiring preparation of an EIS. Answer the questions briefly, with the most precise information known, or give the best description you can.

You must answer each question accurately and carefully, to the best of your knowledge. In most cases, you should be able to answer the questions from your own observations or project plans without the need to hire experts. If you really do not know the answer, or if a question does not apply to your proposal, write "do not know" or "does not apply." Complete answers to the questions now may avoid unnecessary delays later.

The proposal also ordains that marijuana production, marijuana processing and marijuana retail are not permitted uses during the 12 month period. The Ordinance may be extended for additional six month periods by the Board of County Commissioners following a public hearing.



D. SUPPLEMENTAL SHEET FOR NONPROJECT ACTIONS

Because this proposal is to enact a moratorium and interim zoning ordinance, its goal is to preserve the status quo. The goal of this Ordinance is to ensure that any increases in these types of impacts from Marijuana establishments are adequately addressed, and if necessary mitigated before they are allowed in the unincorporated County.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

Because this proposal is for a moratorium and interim ordinance that preserves the status quo, it is unlikely that there would be any impact to plants, animals, fish or marine life.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

3. How would the proposal be likely to deplete energy or natural resources?

Because this proposal is for a moratorium and interim ordinance that preserves the status quo, it is unlikely that there would be any depletion of energy or natural resources directly resulting from this proposal. Depending on where marijuana retailers are eventually located, there may be a slight increase in end-users driving to locations where marijuana is allowed to be purchased. However, such a possible increase is likely offset by a lack of people driving to unincorporated Walla Walla County to purchase marijuana at retail locations.

Proposed measures to protect or conserve energy and natural resources are:

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

Because this proposal is for a moratorium and interim ordinance that preserves the status quo, it is unlikely that there would be any negative impact to environmentally sensitive areas from this ordinance. By enacting this ordinance, the County is ensuring that such impacts from marijuana establishments may be addressed in the future.

Proposed measures to protect such resources or to avoid or reduce impacts are:

Enactment of this ordinance.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

Because this proposal is for a moratorium and interim ordinance that preserves the status quo, it is unlikely that there would be any negative impact to shoreline uses.

Proposed measures to avoid or reduce shoreline and land use impacts are:

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

Because this proposal is for a moratorium and interim ordinance that preserves the status quo, it is unlikely that there would be any negative impact. As noted above, there may be a slight increase in County residents traveling to purchase marijuana in areas where it is allowed, but such traveling would likely be offset by a lack of travelers coming into Walla Walla County to purchase marijuana. Additionally, as noted in the proposed Ordinance, the Ordinance should mitigate any negative impacts to law enforcement services that were discussed in the Liquor Control Board's June 3, 2013 SEPA Checklist.

This ordinance is in compliance with state law, which allows moratoriums and interim development regulations. This ordinance is also in compliance with Federal Law, which prohibits marijuana as a controlled substance.
