RESOLUTION NO. 10 287

**WHEREAS**, pursuant to Walla Walla County Resolution 10 253, Walla Walla County approved an Intergovernmental Agreement between Walla Walla County and the City of Walla Walla to establish a Walla Walla Joint Community Development Agency as a means to provide services more efficiently and cost-effectively to citizens; and

**WHEREAS**, said Intergovernmental Agreement provides that the agency shall be managed by a three member board, with one member to be appointed by and serve at the pleasure of the Board of County Commissioners; one member to be appointed by and served at the pleasure of the Walla Walla City Council; and one at-large member to be jointly appointed by the two jurisdictions; and

**WHEREAS**, pursuant to Walla Walla County Resolution 10 254, the Walla Walla County Board of Commissioners appointed County Commissioner Greg Tompkins to the Walla Walla Joint Community Development Agency Board to represent the county; and

**WHEREAS**, the Walla Walla City Council adopted Resolution No. 2010-72 on October 6, 2010 appointing Councilmember Jim Barrow to represent the City Council on the Walla Walla Joint Community Development Agency Board; and

**WHEREAS**, the at-large board position was publicly advertised and applications sought; and

**WHEREAS**, subsequent to the closing date for applications, one member of the Board of County Commissioners and one City Councilmember were appointed by their respective legislative bodies to jointly review the applications received and make recommendations regarding the appointment of the at-large board member; and

**WHEREAS**, subsequently Bill Clemens was recommended for appointment as the at-large member to serve on the Walla Walla Joint Community Development Agency Board, and after review of the recommendation, the Board of County Commissioners concurs; and

**WHEREAS**, this date, after discussion, a motion to appoint Bill Clemens at the at-large member to serve on the Walla Walla Joint Community Development Agency Board was approved; now therefore

**BE IT HEREBY RESOLVED** by this Board of Walla Walla County Commissioners that they do hereby appoint Bill Clemens to serve as the at-large member on the Walla Walla Joint Community Development Agency Board.

**BE IT FURTHER RESOLVED** that the Clerk of the Board is directed to provide a copy of this resolution to the City of Walla Walla for consideration and action.
