In late September 2013, a STEM Committee composed of administration, staff, and faculty began meeting on an every other week basis to develop a STEM Academic Plan as part of the strategic plan. This was completed in early November and set the stage for developing the capital building project request. In mid-November a contract was established with the ALSC Architect Firm in Spokane, Washington to help develop the STEM Education and Training Center capital project request. Since late November sessions between WWCC representatives with ALSC architects have resulted in the following:

- Facility Review at WWCC.
- Vision Session for Master Facility Plan college wide input.
- Program Interviews with faculty and staff associated with the proposed programs to be placed in new STEM building.
- Listening sessions with representatives from industry and business.

- ALSC Architects and WWCC staff meeting with City Planners.
- Analyze site options on campus for new building placement.
- Develop Cost Estimates.
- Write Capital Project Proposal Request (PPR).
- Develop maps and graphs to support PPR.

- WWCC Board of Trustees approval of STEM Building Project Proposal Request (February 19, 2014 Board meeting).

The Capital Project Proposal Request will be submitted to the State Board of Community and Technical Colleges on February 28, 2014.

3. <u>Does this project qualify as economic development and does it create or retain family wage jobs?</u>
(Please review Attachment A - Principle Guidelines for the Economic Development Sales Tax Fund.)

Washington State has a STEM driven economy. Yet a critical skills gap exists between STEM employment needs and our state's ability to fill these jobs. Of the 25,000 unfilled jobs in WA due to this skills gap, 80 percent are in high-skill STEM and health care fields. By 2017 Washington State will create an additional 110,000 new STEM jobs. Wages for these unfilled jobs are excellent: STEM careers in Washington State are 9th highest in the nation, and wages for health careers are the 7th highest in the nation. Walla Walla Community College (WWCC) is committed to providing students access to these career opportunities.

WWCC's location in the SE corner of WA State situates the college as a key provider of higher education for several large rural districts. WWCC has one of the highest participation rates of its constituents in the state—proof of the College's pivotal role in providing relevant learning opportunities that lead to academic transfer and workforce training degrees. WWCC has been recognized nationally as a critical contributor to the region's economic development. The college has focused on programs that address the economic needs of the region, effectively strengthening the economic base of the Walla Walla Valley. The proposed STEM Center capital project will help reduce the skills gap, and do so by providing access to high-wage professions for place-bound citizens in rural Washington. 6

Economic Modeling Specialists International (EMSI) has validated the needs for programs included in the project and projects the economic impact. Their finding states the potential impact on annual earnings from graduates is \$2.7 million in annual earnings to the regional economy. They also estimate an increase in lifetime earnings of each graduate to be \$470,000. (See Attachment #3)

Additionally, creating clear pathways for students in the field of agriculture science, production, and business, as well as in bio-fuels and mechatronics is critical to Washington State's economic growth, as the food and agricultural industry annually employs an estimated 160,000 people and contributes 12% to the state's economy. WWCC's STEM Center will provide greater capacity to reduce the STEM skills gap and to increase educational attainment rates in the Walla Walla Valley and within Washington State.

Walla Walla's poverty level is 63.4% greater than the Washington average and 46.4% greater than the national average. The median household income in Walla Walla is 33.6% less than the Washington average and 24.7% less than the national average. The large agriculturally based economy of the Walla Walla region attracts a Hispanic labor force whose opportunities for stable professions and living wages are limited. The demographic composition of WWCC reflects on a micro scale the overall demographics of the wider service districts. Nineteen percent of WWCC's student population identifies as Hispanic, and during the past five years the College ranked highest in the CTC system in the percent of students receiving need-based financial aid in eligible programs (78.8% compared to 46.7% statewide). Integral to the College's strategic plan is to cultivate equity through access to applied and transfer STEM workforce pathways—targeting rural, minority, unskilled, underemployed, and unemployed citizenry.

6. <u>Does your organization have an active interest and involvement in economic development?</u> Please explain?

Yes. Job creation and wage improvement result from increased productivity. The three primary drivers of productivity in the economy are talent in the workforce, private and public investment, and infrastructure. Studies are confirming that a highly-skilled workforce is the essential condition for a healthy economy. This remains central to WWCC's mission. Since the late 1990s our region has experienced a significant loss of jobs in the agriculture sector as well as timber business. WWCC had the largest number of unemployed workers enrolling in retraining programs in the state of Washington. While some graduates had to leave the area because jobs were not available in the county, many were able to stay because they had skills that made them valuable to employers in our area.

WWCC also has played a significant role in reinventing our regional economy. Helping create a wine, food, and art cluster is the most visible example, but we are also significantly involved in the health cluster, agriculture cluster, and business and finance clusters. The College is known for aligning our programs with the needs of the regional economy based on economic studies. We also have determined the economic impact of all our contributions to our regional economy. Most rural areas continue to experience significant economic decline and have not recovered from the great recession. Walla Walla is an exception, although we have a very serious income disparity challenge and high unemployment rates for our unskilled population. Providing unskilled and unemployed or underemployed workers with the skills to enter the workforce may be our biggest economic challenge not only in Walla Walla, but our entire nation.

Construction of a STEM Education and Training Center is an important step and we want the Port of Walla Walla as a partner in this effort.

7. Will this project upgrade existing public infrastructure or build new public infrastructure? Please explain?

If facilities for an Educational System is considered public infrastructure, that's what this project is about. 





I am pleased to present EMSI's estimates of the economic impacts of Walla Walla Community College's (WWCC) proposed STEM capital project and program expansion on the Walla Walla campus. Two impacts are estimated: the impact of the project's spending and the impact of increased earnings of the additional students who complete programs housed in the new facility. The results of the impact analysis are outlined below.

The project has a proposed maximum budget of \$17.6 million. Using Walla Walla's surrounding zip codes as an economic backdrop, we estimate the project's spending will generate an additional \$8.9 million in sales and an additional \$4.6 million in income within the region. This is roughly equivalent to 91 jobs paying the average regional earnings of \$50,300.

The capital project will provide the necessary resources to expand program offerings and significantly increase enrollment capacity. Once completed, we estimate approximately 265 additional full-time equivalent students will enroll in STEM and various other programs. Assuming a 58% completion rate, WWCC-Walla Walla will produce an additional 154 completers. Upon graduation, these students will enjoy an average hourly wage of approximately \$18.26 – providing an increase of \$5.19 per hour over the estimated entrance hourly wage of \$13.07. This is equivalent to additional earnings of \$10,801 annually. These higher earnings and the increased productivity of the graduates have an annual impact of over \$2.7 million in added income for the regional economy. Considering the average age of 'graduates and the anticipated number of years in the workforce, graduates will each enjoy \$470,000 in higher lifetime earnings.

Please note the effects detailed above only represent a subset of the overall impacts. For example, they do not include the additional impacts of new student spending in the region while attending WWCC-Walla Walla or the positive societal externalities associated with additional education. Nonetheless, we hope this analysis provides some insight into the potential economic benefits of this project. Please let us know if we can help in other ways.

Due to a lack of response from Katherine Redar and Jennifer Matson with regard to scheduling SHARP interventions or to sign their Personal Services contracts, we propose to nullify those contracts and to provide a Personal Services contract with Sharie Ledford, RN, an experienced RN and HIV educator who is willing and able to fulfill such a contract. The contract requires training in and delivery of Sexual Health and Adolescent Risk Prevention (SHARP), an evidence-based intervention for a minimum of 25 at risk youth through the Juvenile Justice Center which supports the curriculum and offers space and access to youth both in detention and in Pathways Back. During FFY 2013, 26 youth received the SHARP intervention.

Funding for this project is the balance of that awarded to WWCHD through the Washington State Personal Responsibility Education Program (WA PREP) via Cardea Services. The remaining funds will cover all costs of the program including training and implementation of SHARP in 2014.

The funding award is from WAPREP (Washington State Personal Responsibility Education Program), a teen pregnancy prevention program funded by the Administration for Families and Children through the Patient Protection and Affordable Care Act of 2010. This funding was established to decrease disproportionate teen birth rates, pregnancies and sexually transmitted infections among at risk youth at the middle school and high school development level (primarily ages 11-18). The purpose of WA PREP is to increase capacity of intervention partners to use evidence-based interventions to educate adolescents on both abstinence and contraception for the prevention of pregnancy and sexually transmitted infections, including HIV/AIDS and at least three adulthood preparation subject (Healthy Relationships, Parent-Child Communication, and Healthy Life Skills).

This project addresses one of Walla Walla County's Community Health Improvement Plan priority areas: reduction of Communicable Disease/Teen Pregnancy.

RECOMMENDATION:

The Walla Walla County Board of County Commissioners approve renewal of the personal services contract with Sharie Ledford and authorize the Public Health Administrator to sign.
