WHEREAS, in 2014, the Board of County Commissioners, pursuant to Walla Walla County Resolution 14 148, set a public hearing to consider declaring certain county real property, commonly identified as 310 West Poplar Street, 320 West Poplar Street, 328 West Poplar Street, and associated parking lots, as well as the parking lot located at the southwest corner of West Alder Street and Fifth Avenue, all in Walla Walla, Washington, formally identified as Walla Walla County parcel numbers 36-07-29-52-0509, 36-07-29-52-0508, 36-07-29-52-0506, 36-07-29-52-0501 (see respective legal descriptions on the attached "Exhibit A - Legal Descriptions" page, which is by this reference made a part hereof) as surplus to County needs; and

WHEREAS, subsequent to a public process, the Board of County Commissioners, on July 14, 2014, approved a motion that no final action be taken on the possible surplus declaration and disposal; rather, to postpone the matter for an indefinite period, to allow further information to be gathered; and

WHEREAS, as listed on the agenda for the open, public meeting of the Board of County Commissioners on January 4, 2016, discussion was held regarding these properties, and immediately thereafter the Board approved a motion to re-start the process to consider declaring these properties as surplus to the County's needs, and directed the Clerk of the Board to prepare a resolution for consideration; and

WHEREAS, it is proposed to dispose of said property by way of a sale open to the public; and

WHEREAS, pursuant to RCW 36.34, the Board of County Commissioners, as the county legislative authority, is required to set a date of public hearing to consider testimony for and against disposing of any County property; now therefore

BE IT HEREBY RESOLVED by this Board of Walla Walla County Commissioners that the date of Monday, January 25, 2016 at the hour of 9:30 a.m. or as close thereto as possible be set for a public hearing to consider declaring said County property as surplus and to request the Treasurer to dispose of same at a sale open to the public. The Board may also consider setting a minimum price for such sale.

BE IT FURTHER RESOLVED that the Clerk of the Board of Walla Walla County Commissioners shall give notice of said hearing in the manner prescribed by law.

 - Still dealing with inventory

 - Now month to month with CAI (Jail and SHE)
 - Picture link reduced to JJC only

- Go live for Jail is January 26.
- Data conversion comes later – but our current vendor gave us permission to access the current tables without cost.
- Will have to operate on 2 systems for at least half a year until done, and will have to pay to run our current system as well as the new system.
- **Superior Court 1-2 Updates**
 - When these projects are complete I will start on the RFP/Q for the final phase
 - I have sent the list of the final phase equipment needs to a vendor so see if they can help with the design to control all the new features in the courtrooms. (Video, audio, document display, recording etc.)
- **Superior Court – Content Management System (case/document management)**
 - No update
- **Cameras**
 - Progress – waiting for Tom to look at the locations. Not much I can do until then.
- **Backup Storage**
 - Progress – we have deleted some un-needed files from storage and were able to recover some storage, but not near enough to keep us from looking into alternatives for expansion.
- **Public Record Requests Last 2 Weeks**
 - 6 = Requests received
 - 2 = Forwarded to departments
 - 5= Completed
 - 5 = Total Open
 - 5 = Being handled by the PRO (Estimate 1 request to take 50 days)
 - I have got little else done over the last few weeks than working on Public Records

 - Looking for a search tool that will let me target public records request more easily.

 - 2 have had retention services turned on
 - Targeting some specific departments to fill up another class. This time 10-12 employees


