WALLAWALLA COUNTY CONSERVATION DISTRICT PROPOSAL FOR SERVICES For Voluntary Stewardship Program

OVERVIEW

Walla County Conservation District (WWCCD) is pleased to submit this proposal for services to support Walla Walla County in achieving its requirements for implementing the Voluntary Stewardship Program (VSP) within the boundaries of the county. Walla Walla County is subject to the requirements of the Growth Management Act (GMA) and opted to participate in the VSP pending availability of funds for implementation from the legislature. The VSP is the culmination of a statewide effort to bring heretofore exempt agricultural activities into compliance with a State Supreme Court decision that counties must regulate agricultural activities under critical areas requirements of the Growth Management Act.

BACKGROUND OF VSP

- 1. Purpose: VSP was enacted by the legislature to create a voluntary process which counties could "opt in" to achieve GMA goals (RCW 36.70A.700 & RCW 36.70A.710)
- 2. Scope: In general, VSP's goal is to "protect and enhance critical areas on lands used for agricultural activities through voluntary actions by agricultural operators". (RCW 36.70A.705) The law requires that VSP protect critical areas and maintaining and improving the long term viability of agriculture. In addition, VSP may also voluntarily enhance natural resources.
- 3. Funding: Once the Washington State Conservation Commission makes funds available to a county that has made the election provided in RCW 36.70A.710 the county must act within sixty days.
 - a. Walla Walla County "opted in" to the VSP program on January 17, 2012 through Resolution 12-015
 - b. Walla Walla County has nominated all watersheds within the county to participate in VSP.
 - c. The WA State Conservation Commission has provided \$150,000 per county in VSP funding for FY2016
 - d. The WA State Conservation Commission has provided \$120,000 per county in VWP funding for FY2017
- 4. Work Plan Development: In order to develop a Work Plan, Walla Walla County must complete the following:
 - a. Within sixty days of funds being available, the county must designate an entity to administer the funds
 - b. County may designate itself, a tribe, or other entity to coordinate the required watershed group
 - c. Within sixty days of funds being available the county must designate a watershed group
 - d. County must confer with tribes and stakeholders before designating the watershed group.

OUR PROPOSAL

The Walla Walla County Conservation District is hereby proposing that Walla Walla County designate the WWCCD as the entity responsible for administering VSP funds and coordinating the VSP Watershed Group. WWCCD has a well-deserved reputation as a technically competent, locally lead special purpose district with a close relationship with the Walla Walla County agriculture community as well as the agencies that sponsor and fund programs that will be an integral part of the VSP strategy.

The primary goals of the proposed scope of work are to: 1) Organize, facilitate and provide leadership to a Watershed Group that will develop the VSP Work Plan and 2) facilitate development of a Work Plan that provides protection of critical areas of

Walla Walla County while maintaining the viability of agriculture, and 3) submit completed VSP Work Plan to the director of the Conservation Commission for approval.

Note—This proposal is for 1 year and 6 months of work on VSP for Walla Walla County plus an additional year of work offered as an optional item. The rationale for the optional year of work is that RCW 36.70A.700 allows 2 years and 9 months to get the VSP Work Plan approved.

SCOPE OF WORK

Task 1. VSP Management and Administration

- A. WWCCD will manage and administer all aspects of the work described in this scope of work. WWCCD will work closely with the Walla Walla County Community Development Department to ensure full compliance with the requirements and intent of VSP. Responsibilities will include but not be limited to: 1) submittal of vouchers and invoices, 2) maintenance of records, 3) preparation of progress reports, 4) compliance with applicable procurement and contracting procedures and laws, 5) compliance with requirements of interlocal agreement.
- B. WWCCD will ensure that every effort is made to maintain effective communication between the VSP Watershed Group, Walla Walla County, local stakeholders, and participating state and federal agency personnel.

Deliverables:

- 1. Effective management and administration of the project
- 2. Maintenance of all project records
- 3. Timely submission of all required performance items such as vouchers, fiscal records and quarterly progress reports
- 4. Timely signature of a funding agreement with Walla Walla County

Task 2. Watershed Group Organization and Facilitation

WWCCD has participated in a number of watershed restoration forums and groups throughout the Snake River Resource Area for the past decade and is familiar with stakeholders associated with natural resources in the Walla Walla Basin and beyond. WWCCD has been serving the agricultural community in Walls Walla County since the 1940s and is quite familiar with agriculture, landowners and operators in the County. WWCCD will utilize its unique capability to organize a functional VSP Watershed Group.

- A. WWCCD will organize and select members of a VSP Watershed Group with representatives from a variety of stakeholder groups including but not limited to tribes, environmental groups, and agriculture.
- B. Develop meeting bylaws/rules/policies.
- C. Provide facilitation (either in-house or consultant) for VSP Watershed Group meetings which are expected to be monthly.

Deliverables:

- 1. Organization of a vetted core VSP Watershed Group comprised of 10 voting members (1 livestock producer,1 dryland farmer, 1 irrigated farmer, 1 hobby farm, 1 vineyard/orchardist, 1 CTUIR, 1 environmental, 1 WDFW, 1 Walla Watershed Management Partnership, 1 Regional Fisheries Enhancement Group)
- 2. Well-developed meeting bylaws/rules/policies
- Facilitation of meetings and other actions of VSP Watershed Group including communications, agendas, minutes, etc.
- 4. Monthly meetings of VSP Watershed Group voting members and interested public

Task 3. Facilitate VSP Work Plan Development

The 10 year VSP Work Plan will be developed by the VSP Watershed Group which represents the interests of an array of stakeholders as described in Task 2. The Work Plan will be designed to protect critical areas while maintaining the viability of agriculture. The work plan must include goals and benchmarks for the protection and enhancement of critical areas. The VSP Work Plan must be approved by the WA State Conservation Commission within 2 years and 9 months from the date VSP funding are made available to the County.

- A. WWCCD will facilitate the VSP Watershed Group which will complete the following VSP Work Plan as per RCW 36.70A.720. The VSP Watershed Group will:
 - a. Identify critical areas and agricultural activities within those critical areas
 - b. Identify public outreach plan to contact landowners
 - c. Identify and designate entity(ies) to provide landowner assistance (voluntary stewardship plans) RCW36.70A.720 (1)(f)
 - d. Identify measurable programmatic and implementation goals and benchmarks
 - e. Review and incorporate applicable water quality, watershed management, farmland protection, and required species recovery data and plans RCW36.70A.720 (1)(a)
 - f. Seek input from tribes, agencies and stakeholders RCW36.70A.720 (1)(b)
 - g. Develop goals for participation by agricultural operators conducting commercial and noncommercial agricultural activities in the watershed necessary to meet the protection and enhancement benchmarks of the work plan RCW36.70A.720 (1)(c)
 - h. Ensure outreach and technical assistance is provided to producers and operators in the various watersheds RCW36.70A.720 (1)(d)
 - i. Create measurable benchmarks that, within 10 years after receipt of funding, are designed to result in (i) the protection of critical areas functions and values and (ii) the enhancement of critical areas functions and values through voluntary, incentive based measures RCW36.70A.720 (1)(e)
 - j. Incorporate into the work plan any existing development regulations relied upon to achieve the goals and benchmarks for protection of critical areas RCW36.70A.720 (h)
 - k. Establish baseline monitoring for:
 - j. Participation and implementation of voluntary stewardship plans and projects
 - ii. Stewardship activities
 - iii. Effects on critical areas and agriculture relevant to protection and enhancement benchmarks RCW36.70A.720 (1)(i)

- Develop timeline for periodic evaluations, adaptive management, and provide written reports of plan status/accomplishments to the Board of County Commissioners and WSCC
- m. Coordinate monitoring programs with other state agency activities

Task 4. Public Outreach and Technical Assistance

The VSP Watershed Group will develop ideas to communicate plan information and updates to the public. It is important to the overall success of VSP that the public is kept informed and engaged in the process.

- A. The VSP Watershed Group will utilize existing outreach tools (e.g. WWCCD newsletter) to the extent possible to keep Walla Walla County landowners and the public informed as to the status and potential requirements that will be addressed in the VSP Work Plan.
- B. The VSP Watershed Group will continually encourage public and landowner input into the VSP Work Plan development process.
- C. The Watershed Group will develop a website for VSP process. This website will include program description, goals, and products for public review. It will also include meeting minutes, dates and agendas for future meetings.
- D. Public informational meetings will be held as needed
- E. Additional public outreach will be determined by the Watershed Group
- F. The Union Bulletin and Waitsburg Times newspapers will be the primary media for publication of public meetings as well as invitations for input into the VSP process and work plan.
- G. WWCCD will provide technical assistance to operators/producers of funding is available.

IN THE MATTER OF INITIATING COUNTY PARTICIPATION IN THE STATE VOLUNTARY STEWARDSHIP PROGRAM AND TO DESIGNATE A WATERSHED GROUP

RESOLUTION NO.

WHEREAS, during the 2011 Legislative Session, the Washington State Legislature enacted, and the Governor signed, Engrossed Substitute House Bill 1886; and

WHEREAS, Engrossed Substitute House Bill 1886 created the Voluntary Stewardship Program, an alternative program to protect critical areas where agricultural activities are conducted, as recommended by the William D. Ruckelshaus Center to the Legislature; and

WHEREAS, Engrossed Substitute House Bill 1886 was codified as RCW 36.70A.700 et seq; and

WHEREAS, RCW 36.70A.710 states that a County must adopt an ordinance or resolution by January 22, 2012, electing to participate in the Voluntary Stewardship Program and identifying the watersheds that will participate in the program; and

WHEREAS, on January 17, 2012, by Resolution No. 12-015, the Board of County Commissioners elected to "opt-in" (participate) in the Voluntary Stewardship Program for all watersheds in the County, pending eventual funding by the State; and

WHEREAS, the State has notified the Board of County Commissioners that funding for the program is now available in the amount of \$150,000 in the first year, and \$125,000 in succeeding years; and

WHEREAS, the County has substantial interests protecting and enhancing critical areas, and maintaining and enhancing the viability of agriculture; and

WHEREAS, state law requires the County to appoint a watershed group to develop the County's work plan for Voluntary Stewardship Program implementation; and

WHEREAS, per RCW 36.70A.715(2), the County must confer with tribes and interested stakeholders before establishing the watershed group and has done so by requesting comment on this resolution; and

WHEREAS, the Board makes the following Finding of Fact and Conclusions of Law:

- 1. Walla Walla County contains the following watersheds: (1) the Walla Walla River and its tributaries, including, but not limited to the Touchet River, Mill Creek and Dry Creek; (2) the Columbia River and its tributaries; and (3) the Snake River and its tributaries.
- 2. These watersheds have been grouped into Water Resource Inventory Areas 32 and 33, which are mapped at WAC 173-500-990. Portions of Water Resource Inventory Areas 32 and 33 are outside of Walla Walla County.
- 3. As stated in the Walla Walla County Comprehensive Plan, at section 6.3.3, most of the County's unincorporated land, approximately 741,165 acres, is in agricultural use, including both crop and rangeland.
- 4. Walla Walla County has a diverse agricultural base, including grain, livestock, onions, orchards and vineyards. These crops and products are spread throughout the County.
- 5. Approximately 717,474 acres have been designated as agricultural land of long-term commercial significance. Of those, approximately 23,000 acres have been designated as Agricultural Lands of Primary Significance. *Id.*

- 6. In 2002, the U.S. Department of Agriculture National Agricultural Statistics Service Census of Agriculture reported that there were 890 farms and 700,560 acres in agricultural production in Walla Walla County. *Id.*
- 7. In 2002, the value of agricultural production in the County was \$339,093,000, ranking the County at fifth among all counties in the State. *Id.*
- 8. Risk of conversion of farmland to other uses could increase, if Critical Area regulations make agricultural production cost prohibitive.
- 9. The overall likelihood of completing a successful program in the County is high. Farmers have routinely cooperated with voluntary programs such as those offered through the Walla Walla County Conservation District.
- 10. Unique local programs such as the Walla Walla Watershed Management Partnership, the Walla Walla Basin Watershed Council (in Oregon), and the Snake River Salmon Recovery Board provide a strong base of existing watershed programs to provide input into a program established under the Voluntary Stewardship Program.
- 11. As noted in the Walla Walla Comprehensive Plan, "the future of the County's economy will continue to be inextricably tied to the fortunes of the agricultural sector." *Id. at* 6-26.
- 12. Because agriculture is equally important to all areas of the County, it is appropriate that all watersheds within the County participate in the Voluntary Stewardship Program.
- 13. The Conservation District has provided a proposal for services to support Walla Walla County in achieving its requirements for implementing the Voluntary Stewardship Program.

NOW THEREFORE,

BE IT HEREBY RESOLVED, by this Board of Walla Walla County Commissioners, Walla Walla County does hereby initiate participation in the State's Voluntary Stewardship Program (VSP) as provided in RCW 36.70A.710.

All watersheds in Walla Walla County, which are all watersheds within those portions of WRIAs 32 and 33 that are located in Walla Walla County, including but not limited to the Walla Walla River and its tributaries, the Columbia River and its tributaries and the Snake River and its tributaries, shall participate in the Voluntary Stewardship Program.

Walla Walla County designates the Walla Walla County Conservation District as the entity responsible for administering VSP funds, coordinating the VSP Watershed Group, developing a work plan that provides protection of critical areas of the County while maintaining the viability of agriculture, and submitting a completed VSP Work Plan to the director of the State Conservation Commission for approval, as fully described in its proposal for services submitted to the County.
