Contract with Perteet for completion of FMAG-HMGP Pilot Program application

I am requesting signature of a personal service contract with Perteet, Inc. for the maximum amount of \$1500 for the completion of two (2) Fire Management Assistance Grant (FMAG) -Hazard Mitigation Grant Program (HMGP) Pilot program applications. The opportunity for grant funding is a direct result of the FEMA FMAG Declaration for the 2015 Blue Creek Fire.

Walla Walla County submitted pre-applications, and would like contract with Perteet for completion of HMGP applications, for:

- Update of the Walla Walla County Multi-Jurisdiction Hazard Mitigation Plan and Hazard Identification and Vulnerability Assessment.
- Partner with Walla Walla County Fire District #4 for targeted fuels mitigation/reduction work in the Wildland Urban Interface using Department of Corrections labor.

Due to the complexity of the HMGP application, my representative at Washington Military Department, Emergency Management Division, Timothy Cook, recommended use of a contractor. Also, FEMA's evaluation of Walla Walla County's ability to respond to a radiological emergency presents a conflict for completing the applications in-house. Our dress rehearsal is February 24 and the evaluated exercise is March 30. This evaluation occurs every 8 years and it is critical that we are successful. The FMAG - HMGP Pilot Program projects/applications are due March 29, 2016.

Jesse Nolte indicated that we can hire Perteet as a consultant without concern as to whether they are on the engineering roster or going through an RFP/RFQ process. He has also reviewed the contract.

IN THE MATTER OF A WAIVING COMPETITIVE BIDDING REQUIREMENTS PURSUANT TO AN EMERGENCY DECLARATION REGARDING WATER LEAKS ON THE COUNTY FAIRGROUNDS, A PUBLIC PROPERTY

RESOLUTION NO.

WHEREAS, pursuant to RCW 36.40.180, upon the happening of any emergency or for the immediate preservation of order or of public health or for the restoration to a condition of usefulness of any public property, the Board of County Commissioners may, upon the adoption by the unanimous vote of the commissioners present at any meeting the time and place of which all of such commissioners have had reasonable notice, of a resolution stating the facts constituting the emergency and entering the same upon their minutes, make the expenditures necessary to meet such emergency without further notice or hearing; and

WHEREAS, Walla Walla County Fairgrounds Manager Daryl Hopson reported to the Board of County Commissioners on February 8, 2016 during an open public meeting of the Board, as well as informally prior to that and subsequently, regarding serious water pipe leakage on the fairgrounds and a search thereon to locate a cause and determine a solution; and

WHEREAS, Mr. Hopson has determined, working with the City of Walla Walla as water supplier to the fairgrounds, that currently an unusually high amount of water usage, 261 gallons per hour or over 6,200 gallons of water per day, resulting in damage to the grounds and a financial loss due to the leaks; and

WHEREAS, the County Fairgrounds is a public property that is utilized by renters, members of the public, and county employees daily, and currently the water thereon has been shut off, with no water available for use in the buildings or bathrooms on the grounds and necessitating portable bathroom units to be rented and utilized; and

WHEREAS, RCW 39.04.280 provides uniform exemptions to competitive bidding requirements utilized by municipalities when awarding contracts for public works and contracts for purchases, and allows competitive bidding requirements to be waived by the governing body of the municipality for purchases in the event of an emergency; and

WHEREAS, on February 10, 2016 Mr. Hopson has requested, for the restoration to a condition of usefulness of this public property, permission to waive the competitive bidding requirements in this emergency situation; and

WHEREAS, the Board of County Commissioners has considered the situation; and:

- 1) The Fairgrounds Manager is authorized to enter into contracts and incur obligations necessary to combat this emergency and for the restoration to a condition of usefulness of this public property.
- 2) Due to the emergency situation, authority for paragraph 1 above may exercised without regard to time-consuming procedures and formalities prescribed by law regarding purchasing and acquisition of goods and services (excepting mandatory constitutional requirements).
- 3) Any such expenditures shall be tracked and must be within current budget authorizations unless separate supplemental authorization is provided by the Board.

BE IT RESOLVED the Board shall approve this resolution stating the facts of the emergency at that pursuant to RCW 39.04.280, competitive bidding requirements shall be waived and that necess contracts shall be awarded by the county to address the emergency.
