Department Update

<u>Reviews Completed</u> – In March **309 TRAKIT reviews** were completed (returned) for building permit and land use permit applications.

<u>Building Permits</u> – Approximately **30 building permit applications** are currently open: this includes those actively under review as well as those on hold pending re-submittals by the applicant, and those under second review. One third of these open applications are undergoing Intake Review, which means that they were just submitted.

We issued 60 building permits in March for a total building permit revenue of about \$118,000; 12 of these permits were for new residences.

<u>Current Planning</u> – Approximately **90 land use applications are currently open**. In March, **17 land use applications** were approved. In the four months prior, an average of only 6 land use applications were approved per month.

<u>Code Compliance</u> – Currently there are **49 open cases**. A total of **8 new complaints/reports were logged** in **our Citizen Response Module (CRM)** in March. Currently, we are prioritizing cases that include building and fire code violations.
