ORDINANCE NO. 491

APPROVING A REQUEST BY WALLA WALLA COUNTY PUBLIC WORKS TO AMEND WALLA WALLA COUNTY CODE CHAPTER 10.04, SPEED LIMITS, TO CORRECT CLERICAL ERRORS WITH SPELLINGS OF CERTAIN COUNTY ROADS, TO REMOVE INCONSISTENCIES PERTAINING TO SPEED LIMITS AND TO MODIFY CERTAIN SPEED LIMITS IN UNINCORPORATED PORTIONS OF WALLA WALLA COUNTY.

Whereas, a request was made to lower the speed limit on Beet Road; and

Whereas, the Public Works Department completed a thorough review of Walla Walla County Code Title 10, Vehicles and Traffic, and in so doing discovered typographical errors and roads that had been annexed or had terminus changes; and

Whereas, it is desirable to improve clarity, correct clerical errors with spellings of certain County roads and eliminate inconsistencies to keep the Walla Walla County Code accurate and up to date; and

Whereas, Title 10, Chapter 10.04 was last reviewed and updated on March 7th 2011; and

NOW THEREFORE,

BE IT ORDAINED, by the Walla Walla County Board of County Commissioners that:

Section I. The Board of County Commissioners Makes the Following Findings of Fact:

- 1. The Board of County Commissioners held a Public Hearing for the purpose of receiving testimony on the Beet Road speed limit change on September 27, 2021.
- 2. The County Engineer completed an engineering and traffic investigation as required by RCW 46.61.415 to support recommended changes to the speed limit on Beet Road.
- 3. Notices of a Public Hearing were published in the Walla Walla Union Bulletin on September 9 and September 16, 2021.
- 4. The Public Hearing was continued to October 4, 2021 to allow for additional public comment.
- 5. Several roads listed in Walla Walla County Code Chapter 10.04 have been annexed, have had starting or ending points changed or needed modifications due to typographical errors.
- 6. Some roads needed to be added to the Code.



Section II. The Board of County Commissioners Makes the Following Conclusions of Law:

- 1. The County has reviewed and evaluated comments received from the public.
- 2. The proposed amendments to Chapter 10.04 of the Walla Walla County Code are necessary to improve clarity and to correct clerical errors with the spelling of certain County roads.
- 3. The proposed change to the speed limit on Beet Road is supported by the County Engineer's study and development patterns and usage of Beet Road.
- 4. The proposal meets a definable public need.

Section III. Adoption of Amended Section 10.04.005 of the Walla Walla County Code. The amendments to Title 10, Vehicles and Traffic, resulting in the modification of the Speed Limits Table is **adopted** as presented to the Board of County Commissioners on this date as attached in Exhibit A.

Section IV. Effective Date and Savings. This Ordinance is effective as of the date of signing.

Section V. If any section, subsection, paragraph, sentence, clause or phrase of this ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining parts of this ordinance.

Section VI. This ordinance will be published by an approved summary consisting of the title.





Corrections/Court Services Department Updates:

- ✓ Service Providers, Programs, Grants & Essential Services
 - Jail's Residential Substance Abuse Treatment (RSAT) grant expired 9/30. State Health Care Authority has not yet published RSAT grant RFP for current federal FY which began 10/1/21. Serenity Point Counseling Services advised of current grant status; County and SPCS agreed to wind down RSAT services in the jail effective 10/8/21.
 - Sen. Darnielle announced that she is leaving her seat in the State legislature and has accepted a position with DOC as an Assistant Secretary of Women's Prisons with the State. This resignation from political office was unexpected, and it remains to be seen if Raise the Age 5122 will move forward with the same vigor in the next session. Juvenile departments continue to plan for likelihood that 18's and even 19's could fall under our purview within the next year or two.
 - Court Services PO Vance Norsworthy successfully completed JJC's first Coordination of Services program in September, with all three families referred successfully completing the program.
 - Two Court Services PO's are now providing iACT (Individual Alternative Choice Training) programming for individual youth on their caseloads.
 - Court Services Manager Jon Cassetto recently updated all MOU's with area school district administrators for the provisioning of Truancy intervention services.
- HCA limits the amount of CJTA funding that can be spent inside a jail facility to 15% of base funding, which means \$15,000 of the \$51,222 the County receives may be spent within the jail for CJTA-approved services. Our plan for this state FY was to spend in excess of \$15,000 on MAT for individuals in the facility and the balance of the \$51,222 on assessments, peer-based recovery support services, recovery coaching services and other needs. This means we will need to draw upon our CE medication line at a higher rate and then work with stakeholders to provide CJTA-eligible services outside the facility. Not an impossible challenge, but definitely an unanticipated wrinkle.
- The County was awarded another \$43,000 in supplemental CJTA funding that must be used for therapeutic court client services. We have been using those dollars to assist ARC client needs such as

transportation, rental assistance, virtual treatment access, bill assistance, reading glasses, and educational costs. Other eligible costs include childcare, vocational training, treatment, detoxification, and MAT.

✓ Facilities, Equipment and Technology

- The County's lease agreement with the City for the land upon which Hawk Point Challenge Course sits expired a few years ago. Since then, I have had discussions with City Parks and Recreation about the possibility of the City taking over the course. The pandemic hit, and discussions were put on hold as the next step was to gather a group of stakeholders and decision makers to run them through a half day program at Hawk Point. We have resumed the dialogue and there is strong interest from the City to revive the course.
- The Jail's Axon Tasers are aging and in need of replacement. I will be bringing forward a proposal soon.

✓ Personnel/Training/Recruitment

- A lateral Corrections Officer started October 1st and we have two additional successful PAT/written candidates who made it through interviews and are now in background. Additionally, three of four applicants passed PAT/Written on 10/6 and are scheduled for interviews. We are feeling positive about having some solid candidates in the pipeline.
- A new JDO came on board at JJC in September; a current JDO recently resigned and accepted a position with District Court.
- Detention Manager Becky Renwick's last day at Court Services was October 8th; she starts her new position with District Court October 11th. Becky was with Court Services since August of 1997, first as a detention officer who helped open the new facility in October, 1997, before promoting to Lead Officer and later Intake/Diagnostic Juvenile Probation Officer before taking on the Detention Manger role in 2018. JJC's loss is definitely District Court's win; Becky helped many youth and families in our community and served the Juvenile Division of Superior Court with distinction for 24 years.

MEMORANDUM OF AGREEMENT

Walla Walla Department of Community Health

Arcora Foundation

Parties

This Agreement is entered into by and between Walla Walla Department of Community Health ("Contractor"), a government agency based in the state of Washington and Arcora Foundation ("Foundation"), a not for profit agency based in the state of Washington. Each of Contractor and Foundation may be referred to in this Agreement individually as "Party" and collectively as the "Parties."

Purpose

The purpose of this Agreement is to define mutually agreed upon expectations, deliverables, and support for the MouthMatters/Access to Baby and Child Dentistry (ABCD) Oral Health Collaborative the "Collaborative".

Period of Agreement

The period of this Agreement is from May 1, 2021 and shall terminate on December 31, 2022, unless earlier renewed, completed or terminated. Either party may terminate this Agreement upon thirty (30) days prior written notice.

Background, Expected Outcomes, Deliverables and Expectations

The background, expected outcomes, deliverables and expectations are outlined in the Scope of Work, hereby incorporated into this Agreement as Attachment A.

Foundation Funding Support

The Foundation will provide funding to Contractor up to the amount of \$8,000 to support the activities of the ABCD-MouthMatters Collaborative. Contractor will submit the invoice for the entire contracted amount, and IRS Form W-9, and ACH Form (Electronic Fund Transfer Form) within 90 days of executing this Agreement.

In addition, travel costs incurred to and from the Collaborative in-person meetings shall be supported by the Foundation. At the Contractor's discretion, travel may be paid by the Foundation either (a) as a direct pay to a third party vendor (e.g., hotel), when possible; or (b) on a reimbursement basis to Contractor. All travel must be pre-approved by the Foundation. Travel may include reasonable airfare, mileage, and overnight accommodations. All reimbursements must be accompanied by receipts to document the expense and a completed Foundation Expense Reimbursement Form. Only travel costs that are above the amount contracted under the Health



The Foundation of Delta Dental of Washington

Care Authority ABCD Outreach and Case Management Contract are eligible for Foundation support under this Agreement.

Confidentiality

In the course of performing the Scope of Services, the Parties recognize that Contractor may come in contact with or become familiar with information which the Foundation or its affiliates may consider confidential, or which may be of value to a competitor. Contractor agrees to keep all such information confidential and not to discuss or divulge it to anyone other than appropriate Foundation personnel or their designees.

Intellectual Property Considerations

The Parties agree that any work created for the Foundation during the length of this Agreement shall belong entirely to the Foundation. The Foundation shall own all right, title, and interest in all deliverables, work product, materials, or other results from this Agreement. All deliverables, in whole and in part, shall be deemed works made for hire of the Foundation for all purposes of copyright law, and all right, title, and interest in and to copyright rights therein shall belong solely to the Foundation.

What is an Age-Friendly Health System?

Age-Friendly Health Systems is an initiative of <u>The John A. Hartford Foundation</u> and the Institute for Healthcare Improvement (IHI) in partnership with the <u>American Hospital Association</u> (AHA) and the <u>Catholic Health Association of the United States</u> (CHA). As of August 2021, there are over 2400 recognized Age-Friendly Health System participants. Five pioneer health systems stepped forward to work with IHI to test ideas and learn what it takes to be an Age-Friendly Health System. The 4Ms Framework for Age-Friendly Care that emerged is both evidence-based and able to be put into practice reliably in health care settings.

What is an Age-Friendly Public Health System?

<u>Trust for America's Health</u> (TFAH) partnered with The John A. Hartford Foundation with the vision that every public health department should become an Age-Friendly Public Health System (AFPHS) with older adult health as a core function. Public health can address health disparities within the population, and build and maintain partnerships with aging services networks.

The 5Cs of an Age-Friendly Public Health System

- Connecting and convening
- Coordinating
- Collecting and Disseminating Data
- Communicating
- Complementing and Supplementing

TFAH piloted the AFPHS initiative in Florida to test the 5Cs framework for expanding public health's roles in healthy aging, resulting in practice and policy changes. TFAH has developed an <u>AFPHS Recognition Program</u> to incentivize every state and local health department to address older adult health.

The COVID-19 pandemic has highlighted the need for public health to address older adult health, particularly the disproportionate impact on nursing homes residents and staff, and further worsening social isolation.

What is an Age-Friendly Public Health Opportunity?

The Washington State Department of Health (DOH) will work with TFAH to plan and implement a statewide initiative to promote an Age-Friendly Public Health System to improve the health and well-being of older adults within the state of Washington. The focus of this work is to explore and expand public health's roles in healthy aging by:

- Improving health equity among the older adult population
- · Building new partnerships
- Enhancing data collection
- Facilitating local health department and tribal health engagement in older adult health and well-being



What data supports this work?

- In Washington, the percentage of older adults age 85 and older is projected to increase 181% between 2020 and 2040.
- By 2040, a vast majority of counties in Washington will have at least one in five residents over age 65, and slightly more than half of the counties will have more than one in four.
- Aging brings an increase in chronic diseases such as hypertension, diabetes, arthritis, and dementia. 80% of older adults have at least one chronic health condition.
- Alzheimer's disease is the third leading ageadjusted cause of death in Washington.
- The number of Washingtonians diagnosed with Alzheimer's disease is projected to increase 16.7% from 120,000 in 2020 to 140,000 in 2025.
- According to national data, older African Americans are nearly twice as likely to develop Alzheimer's disease than older White Americans and older Hispanics/ Latinos are about one and a half times likely. African Americans are less likely to receive specialized diagnostic evaluations and are diagnosed later in the course of the illness.
- Two thirds of older women will develop Alzheimer's disease.

Topic: New COVID Response Positions

Summary

From the beginning of our local COVID response, back in 2020, we have pulled existing staff to fill roles for the pandemic response. In the beginning, we thought and hoped this would be a short-lived pandemic. However, the pandemic is proving to be a long-term response. With this continued response we also need to sustain our existing programs, but we are finding this difficult when staff are spread thin.

We are requesting the authorization to work with Human Resources (HR) to develop appropriate, temporary COVID response positions to relief existing staff. The two main positions we are currently pursuing are: COVID Vaccine Coordinator and a COVID Public Relations (Vaccine and Testing Equity/Communication).

The vaccine coordinator position would not need to be a registered nurse, but an administrative manager who would coordinate the scheduling and daily activities related to the vaccine process. The public relations position has specific funding and would cross train with the vaccine coordinator position and our communication person, but ideally be able to offer a higher degree of targeted outreach to underserved populations.

We also ask, if we identify other necessary temporary COVID positions that we have permission to work with HR to develop the positions as needed.

Cost

Cost will be based on where positions fall on payroll scale and duration of employment.

Funding

Funding will be Department of Health and/or other COVID funding sources.
