INTERGOVERNMENTAL AGREEMENT CREATING A
MULTI-JURISDICTIONAL NARCOTICS TASK FORCE
FOR THE WALLA WALLA REGIONAL DRUG AND GANG TASK FORCE
(WWRDGTF)TO
COMBAT DRUG TRAFFICKING, ORGANIZED
CRIMINAL GANGS, AND VIOLENT OFFENDERS

This Interlocal Agreement is made and entered into pursuant to the provisions of Chapter 39.34 RCW, by and among the following parties:

Walla Walla County
City of Walla Walla
City of College Place
Washington State Department of Corrections

#### RECITALS

Historically, Walla Walla County, City of Walla Walla, and City of College Place have been underserved and unrepresented with federal funds as it pertains to drug enforcement, criminal gangs, and violent offenders. There has never been sustained, long term regional efforts funded by the federal government.

Currently, only the City of Walla Walla has full-time detectives assigned to the investigation of drug, gangs and career criminals. These detectives are currently assigned to the Walla Walla Police Department (WWPD) Street Crimes Unit (SCU). WWPD SCU currently has one sergeant and five detectives assigned. WWPD foresees losing at least one of these positions to staff patrol for up to the next 18 months. The only other local agencies in Walla Walla are the Walla Walla County Sheriff's Office (WWSO) and College Place Police Department (CPPD). Each of our agencies have struggled to maintain full staffing.

Walla Walla County is surrounded on three sides by federally designated high intensity drug trafficking areas (HIDTA). Franklin County borders us on the North, Benton County borders us on the West and Umatilla County, OR borders us on the South. Walla Walla County is not currently designated as a HIDTA county.

Franklin and Benton Counties contain the Cities of Pasco, Kennewick and Richland, when combined (Tri-Cities) is one of the most populated regions in the State of Washington and only 50 miles away. Walla Walla County has three colleges that bring an additional 10,000 students here annually. In addition, we experience a large population of seasonal migrant workers with direct ties to Mexico.

Hwy 12, Hwy 124 and Hwy 125 are the state highways that connect our region to Tri-Cities, Yakima, Umatilla County, Oregon (10 miles away) and Idaho, which is only 90 miles away. These state highways have long been used to circumvent interstates nearby by drug dealers and gangs.

During the last several years our combined agencies have seized over \$800,000 in drug proceeds, multiple pounds of methamphetamine, heroin, fentanyl, cocaine, marijuana and dozens of stolen firearms. We were able to confirm that several of these seizures were directly tied to Drug Trafficking Organizations in Mexico.

Walla Walla has a regional airport, and the region is served by railroad lines and truck freight companies. The Walla Walla region has several documented criminal street gangs and outlaw motorcycle gangs (OMG) to include the approximately one dozen recently fully patched in Pagans, a DOJ recognized 1 % OMG. All these gangs have state and national ties to their parent organizations. We also have one of the largest state penitentiaries in the State of Washington. Washington State Penitentiary incarcerates a large percentage of the most violent offenders, drug traffickers and gang members. Visitors and family members who live in our region are largely responsible for facilitating drugs into our area and into the prison.

Because of these factors, Walla Walla is known to the mid to upper-level drug traffickers and criminal gangs as a relative "safe zone" due to the lack of sustained, organized mid to upper-level efforts by local law enforcement.

The federal government has appropriated monies to the State of Washington to fund a coordinated state-wide narcotics control program. These funds are currently administered by the Washington State Department of Commerce. The Department of Commerce or a successor state agency will continue to administer these funds.

Based upon established criteria, the parties are eligible to apply for a grant to assist them in their efforts to combat controlled substances trafficking. Department of Commerce desires to enter into a contract with one participating jurisdiction, to be named in the grant application as the applicant jurisdiction, and which shall have the duty of administering the grant on behalf of the participating jurisdictions.

The parties desire to enter into an Agreement to enable the applicant jurisdiction to receive the grant, to administer the grant, and to be responsible for compliance with its terms on behalf of the participating jurisdictions.

The City of Walla Walla has consented to act as the applicant jurisdiction with regard to future applications to Department of Commerce and any funds supplied by a Department of Commerce grant.

Chapter 39.34 RCW provides that local jurisdictions may enter into cooperative agreements in order to best serve the needs of their local communities.

Now, therefore, the parties hereto, through their governing bodies, do hereby agree as follows:

#### SECTION 1 – DEFINITIONS

"Application" means an application submitted to Department of Commerce for a controlled substance law task force grant.

"Agency" and "Agencies" shall mean the member agencies of WWRDGTF, that being the Police Departments of the Cities of Walla Walla and College Place, the Sheriff's Department of Walla Walla County, the Washington State Department of Corrections (DOC), and the Walla Walla County Prosecuting Attorney's Office.

"WWRDGTF" (Walla Walla Regional Drug and Gang Task Force) shall mean the Multijurisdictional Narcotics Task Force for the Walla Walla Region Hereby Established to Combat Drug Trafficking, Organized Criminal Gangs, and Violent Offenders (a/k/a the Walla Walla Regional Drug and Gang Task Force).

"Department of Commerce" means the Washington State Department of Commerce.

"DEA" means Drug Enforcement Administration from within the United States Department of Justice.

"Executive Board" means the oversight committee consisting of one elected or appointed official from the cities of Walla Walla and College Place, to be designated by the City Council of each jurisdiction, and one County Commissioner from Walla Walla, or their designee from among non-judicial elected officials of their county or an administrator working for the County Commissioners. The chairperson of the Governing Board or his/her designee from among its members and the Deputy City Manager of the City of Walla Walla shall be non-voting members of the Executive Board. The Executive Board

shall be the chief administrative officer for the purpose of budget transfers within each fund.

"Governing Board" shall mean the law enforcement policy body for WWRDGTF and will consist of the Chiefs of Police of Walla Walla and College Place, the Sheriff of Walla Walla County, and the Walla Walla County Prosecuting Attorney (WWPA) or a deputy prosecuting attorney designated by the WWPA. It shall recommend the budget for the grants funds and their disbursement and be responsible for preparing applications for any additional grants or renewal of the grant. The Deputy City Manager of the City of Walla Walla shall be a non-voting member of the Governing Board for the purposes of advisement on financial and fund administrative matters. The prosecuting attorney shall refrain from voting on purely investigative issues. The City of Walla Walla Police Chief shall serve as chairperson.

"Jurisdictions" mean the cities of Walla Walla and College Place, and the county of Walla Walla.

"Local Narcotics Control Program Fund" ("LNCPF") means the fund to be administered by the City of Walla Walla for purposes of grant administration and the receipt and disbursement of grant funds.

"WWRDGTF Drug Forfeiture Fund" means a fund of to be established and administered by the City of Walla Walla. This fund may receive the proceeds of forfeiture, federal grants, and the court ordered or other contributions for the purpose of enforcement of the controlled substance laws of the State of Washington.

"WWRDGTF Operations" means any controlled substance law enforcement activity in which an officer assigned to WWRDGTF takes an active part, either as part of a surveillance team, raid team, or an arresting officer. WWRDGTF operations may also include controlled substance law enforcement activity in which WWRDGTF's sole participation was to supply intelligence information to the arresting agency. The Governing Board, in accordance with the provisions of Section 8, shall determine whether the providing of information in any given case has been substantial enough to constitute making that activity a WWRDGTF operation.

"Paid Vouchers" means all purchase orders, invoices, payroll, records, etc., to back up expenditures by participating jurisdictions.

#### **SECTION 2 – PURPOSE**

The purpose of this Agreement is to establish an organized effort to combat violations of controlled substance laws within the contracting jurisdictions and to take advantage of Department of Commerce and any other available grants.

#### SECTION 3 – GENERAL DUTIES OF THE PARTIES

The parties have or shall:

Authorize their respective representative to execute any and all necessary documents to obtain grant funds available pursuant to State and Federal Law for the purpose of establishing a regional, multi-jurisdictional Task Force;

Authorize their officials and employees to participate in the activities of WWRDGTF according to this Agreement, the work plan established in the application, and as determined by the appropriate administrative body; and

Authorize their law enforcement officials to enter into operating agreements, such as those in existence pursuant to Chapter 10.93 RCW to enable these agencies to participate in WWRDGTF.

#### SECTION 4 - DURATION/WITHDRAWAL/TERMINATION

This Agreement shall commence immediately upon its execution by all of the parties and filing with the Auditor of Walla Walla County and shall continue until terminated by the jurisdictions. To comply with the requirements of the Department of Justice, the Governing Board will annually vote to reaffirm the terms and conditions of this Intergovernmental Agreement.

The grant from Department of Commerce is made for one year at a time, beginning October 1<sup>st</sup> of each year. Any party may withdraw from WWRDGTF effective the beginning of the next grant year by giving written notice by no later than 90 days prior to the end of the annual grant cycle to the other parties to this Agreement. A party that withdraws from WWRDGTF before termination of WWRDGTF shall forfeit 100% of their share of the WWRDGTF Drug Forfeiture Fund equity and assets.

Termination of this Agreement shall only occur upon written mutual agreement of all the parties that are at the time of termination participants in WWRDGTF and subject to this Agreement. The written agreement for termination shall be executed by 90 days prior to the end of the annual grant cycle to be effective on that date.

#### SECTION 5 - TASK FORCE

Each party has committed to providing, as long as their respective budgets allow, the following personnel with their assigned equipment to WWRDGTF:

WWPD - 5 Investigator(s)
CPPD - 1 Investigator(s)
WWSO - 1 Investigator(s)
DOC - 1 Investigator

Each party has the option of amending the number of personnel assigned to WWRDGTF. Notice of any change in the number of personnel committed to WWRDGTF shall be given to the Executive Board by January 1<sup>st</sup> of that year to take effect by January 31<sup>st</sup> of that same year.

The WWPD shall supply a supervisory person of the grade of Captain or above to act as a part-time administrator. That person shall serve approximately one-fourth of his/her time administering WWRDGTF. The administrator may be delegated such administrative duties as the Governing Board shall see fit.

Selection and retention of the administrator shall be done by the WWPD Chief. If the majority of the Governing Board does not support selection or retention of the administrator, the City of Walla Walla may either name a different administrator or choose to withdraw as the administering agency.

One of the investigators assigned from the WWPD shall be a Sergeant. That Sergeant will perform supervisory duties in WWRDGTF.

The WWPA will assign a lawyer for the purpose of handling cases generated by the Task Force. The WWPA will commit to not denying any task force generated case due to staffing issues.

Secretarial staff will be assigned or employed by one or more of the parties in the support of the investigation and prosecution of cases arising as a result of Task Force operations and this may be contingent upon funding. This position will be funded 50% from the JAG funding.

The Executive Board, by majority vote may, in the event that any party to this Agreement fails at any time during the term of this Agreement to provide or maintain the commitment of personnel to WWRDGTF as set forth above, impose the following penalties on the party in breach of this Agreement.

The forfeiture of all (100%) of the party's share of the WWRDGTF Drug Forfeiture Fund equity and assets; and

The immediate payment upon determination of amount to the WWRDGTF Drug Forfeiture Fund of an amount equal to any loss of federal and/or state grant funds for the operating year arising from or caused by the party's failure to provide or maintain their commitment of personnel to WWRDGTF.

#### SECTION 6 – ADMINISTRATION

The City of Walla Walla shall be the applicant jurisdiction for Department of Commerce grants. It shall provide the necessary documentation to receive grant funds and ensure that the provisions of the application are met. Walla Walla shall maintain budgetary control of grant funds and maintain records as required by applicable laws and regulations. Participating jurisdictions shall incur, and pay individually, those expenses accruing to activities or employees of their jurisdictions. Paid vouchers for reimbursable expenses are to be transmitted to the Finance Division of the City of Walla Walla immediately after payment. The City of Walla Walla shall request funds for grant reimbursement on a monthly basis and distribute grant proceeds accordingly upon receipt of said funds. The City of Walla Walla shall set up and administer the LNCPF for the purposes of accounting for grant fund receipts and disbursements and to prevent the commingling of grant funds and drug forfeiture and other funds recovered pursuant to this Agreement with any other funds. The LNCPF shall be subject to the same audit and fiscal controls as the public treasury of the City of Walla Walla.

The City of Walla Walla assumes the responsibilities of the applicant jurisdiction on behalf of, and for the benefit of, all the jurisdictions that are parties to this Agreement. All the jurisdictions shall share, on a pro-rata basis, any loss other than a loss covered by Section 10 of the Agreement suffered by any jurisdiction arising solely and directly as the result of the City of Walla Walla's role as the applicant jurisdiction.

In the event that there is any recapture of grant funds by the Department of Commerce pursuant to the provisions of the City of Walla Walla contract with it, the jurisdictions shall share responsibility on the pro-rata basis. However, in the event that there is a recapture of grant funds originally disbursed due to an identifiable discretionary expenditure of any jurisdiction or agency, that jurisdiction or agency shall bear the sole responsibility for payment and indemnify the City of Walla Walla for any loss of funds it may suffer due to any such recapture.

If any loss of funds, other than a loss covered by Section 10 of the Agreement, is covered by a fidelity bond or other insurance, covering one of the jurisdictions employees, that

jurisdiction shall be responsible for said loss to the extent of the coverage provided by said bond or insurance and any remaining loss shall be shared as set forth above.

The City of Walla Walla shall administer the WWRDGTF Drug Forfeiture Fund, and it shall be subject to the same audit and fiscal controls as the public treasury of the City of Walla Walla.

The Executive Board shall be responsible for the budget and all other administrative duties of the LNCPF and of WWRDGTF. The Executive Board may delegate any or all of these duties to the Governing Board. The Executive Board shall be responsible for submitting both the LNCPF budget and the WWRDGTF Drug Forfeiture Fund budget to the City Council of the City of Walla Walla for approval as provided by law. The Executive Board shall elect a chairperson and vice-chairperson, meet at least twice a year, and adopt such procedural rules to govern its meetings as it deems necessary.

The Governing Board shall meet at least quarterly, adopt such procedural rules to govern its meetings as it deems necessary, and provide policy recommendations to the Executive Committee regarding the LNCPF, WWRDGTF Drug Forfeiture Fund, WWRDGTF, and related Task Force expenditures and operations, and may delegate any administrative duties delegated to it.

Nothing in this Agreement shall be construed as authorizing any party or official of said party to direct the Prosecuting Attorney or any Deputy Prosecuting Attorney in the performance of his or her duties.

To comply with WWRDGTF's obligation to respond to Public Records Requests, and to minimize legal risk to each participating jurisdiction, the parties agree that all original police reports, correspondence, e-mail communications, or other "records" related to WWRDGTF operations and investigations shall be provided to WWPD and will be maintained by the City of Walla Walla as the administrative agency. The parties agree that to the extent a participating jurisdiction concludes it needs a copy, it may maintain a copy. When a Public Records Request is received by WWRDGTF, administrative staff for WWRDGTF will complete a search for responsive records and respond to the request. To the extent legal review is needed to respond to a request the City Attorney for the City of Walla Walla will provide the review.

#### SECTION 7 - ACQUISITION AND USE OF EQUIPMENT

In the event that any equipment is acquired with grant funds received from Department of Commerce, the parties agree to use the equipment only for specified program purposes during the life of the grant. All equipment purchased by the City of Walla Walla on behalf of WWRDGTF using grant funds shall be owned by the applicant jurisdiction, the City of Walla Walla. After the grant period ends, the parties agree to use the equipment only for controlled substance enforcement purposes and to dispose of said property as set forth in this Section unless federal and state requirements provide for a different disposition.

Upon termination of this Agreement, all equipment contributed by the jurisdictions shall be returned to the contributing agency. All property and equipment purchased with monies from the LNCPF or with monies from the WWRDGTF Drug Forfeiture Fund shall be distributed so as not to violate the paragraph above, and on a pro-rata basis as set forth below, and this property shall be used by the receiving party only for controlled substance enforcement purposes unless federal and state requirements provide for a different disposition. The Governing Board shall see to it that a separate inventory for property and equipment purchased from each fund shall be kept and, if money from the LNCPF is used to reimburse any other fund for any property and equipment purchased, the property or equipment shall be transferred to the LNCPF inventory. This inventory shall continue for the duration of this Agreement. Upon termination of this Agreement, the items purchased with monies from the LNCPF fund or with monies from the WWRDGTF Drug Forfeiture Fund shall be distributed to each participating jurisdiction under a formula that divides the cumulative number of investigators or prosecutors assigned to WWRDGTF by each jurisdiction starting with the first grant cycle year, and continuing through the most recently completed grant cycle year by the cumulative total of investigators or prosecutors assigned to WWRDGTF by all participating jurisdictions during this same period. Jurisdictions shall only receive credit in the calculation for those investigators that remain assigned to WWRDGTF for the entirety of a fiscal year. At such time that a jurisdiction removes all of the investigators that it had previously assigned to WWRDGTF, it shall also forfeit its right to any future distribution of accumulated assets under this section and be removed from the calculation.

#### SECTION 8 - FUND ADMINISTRATION AND FORFEITURES

All property, proceeds from property, and cash forfeited pursuant to RCW 69.50.505 by WWRDGTF operations and all other contributions to the WWRDGTF Drug Forfeiture Fund shall be managed and disbursed as provided in this Section.

The City of Walla Walla shall administer the WWRDGTF Drug Forfeiture Fund and shall make expenditures from the fund only as appropriately directed. All interest attributed to investment of monies in the WWRDGTF Drug Forfeiture Fund shall be deposited into the fund. This fund shall be established so that it may accept court ordered contribution or other contributions as well as funds disbursed by the federal government or other agencies involving the enforcement of controlled substance laws. Disbursements from this fund shall be for controlled substance enforcement purposes.

To the extent that RCW 69.50.505 requires that the forfeiture funds be deposited in the current expense fund of the jurisdiction in which the forfeiture takes place, that requirement shall be met by depositing said funds in the WWRDGTF Drug Forfeiture Fund. Forfeitures shall be in accordance with RCW 69.50.505 or other applicable law and all funds which may be retained by the local jurisdiction as a result of said forfeiture shall be deposited into the WWRDGTF Drug Forfeiture Fund.

All property forfeited pursuant to WWRDGTF operations shall be immediately delivered to WWRDGTF for use in WWRDGTF operations, unless use of such property is declined by the Governing Board, in which case the jurisdiction in which the forfeiture took place may use the property in accordance with RCW 69.50.505. The City of Walla Walla shall see to it that a property inventory is kept of all the property seized, whether or not it has yet been forfeited, and of its sale or other disposition.

The Governing Board may authorize the transfer of forfeited property of any law enforcement agency in this state upon application for the exclusive use of enforcing the provisions of Chapter 69.50.505 RCW as now or hereafter amended.

Firearms confiscated as a result of WWRDGTF operations will be placed into WWPD or WWSO evidence and the disposal of the firearms will occur after adjudication of the case in court and at the direction of the Governing Board.

Upon termination, the Deputy City Manager of the City of Walla Walla, or his or her designee, using established governmental accounting standards shall determine the balance of the LNCPF and the WWRDGTF Drug Forfeiture Fund available for distribution as of the termination date. All jurisdictions shall share in the amount available for distribution on a pro-rata basis as set forth in section 7. Any balances that become available for distribution within the LNCPF and the WWRDGTF Drug Forfeiture Fund after the date of termination, including but not limited to, the net proceeds derived from any property that was seized or forfeited prior to the termination date, shall be distributed in the same manner, Funds distributed may be used for the expansion of controlled substance enforcement purposes and may not supplant pre-existing funding services unless otherwise authorized by applicable law.

In order to ensure compliance with the Agreement, the parties agree that all forfeitures made pursuant to RCW 69.50.505 by each party shall be disclosed to the Governing Board. The Governing Board shall review each case to determine if the action was a WWRDGTF operation. The decision of the Governing Board shall be binding upon all parties. However, WWRDGTF operations shall expressly not include drug arrests and forfeitures which are incidental to an unrelated activity, e.g., a routine traffic stop, arrests and forfeitures from operations which were made after consultation with and agreement of the WWRDGTF supervisor that WWRDGTF would not participate; and cases which are not considered a WWRDGTF case for prosecution purposes.

#### **SECTION 9 – ARBITRATION**

The parties agree that any dispute arising from this Agreement relating to the distribution of monies and or property or penalty provisions shall be submitted to an arbitrator for a binding decision pursuant to Chapter 7.05 RCW unless the parties agree to another manner of arbitration. If the parties cannot agree on an arbitrator(s), the court shall appoint an arbitrator from a list compiled as follows: each party shall submit a list of three persons not associated with any of the parties who have agreed to act as an arbitrator and each party may strike up to two names from the total list thereby compiled. The court shall select an arbitrator from among the names remaining unless there is none, in which case the court shall select an arbitrator no associated with any of the parties.

#### SECTION 10 - LIABLITIY

Each party shall be responsible for the wrongful or negligent actions of its employees while assigned to WWRDGTF as their respective liability shall appear under the laws of the State of Washington and/or Federal Law and this Agreement is not intended to diminish or expand such liability.

Liability shall be apportioned among the parties or other at-fault persons or entities in accordance with the laws of the State of Washington.

Nothing herein shall be interpreted to:

Waive any defense arising out of RCW Title 51.

Limit the ability of a participant to exercise any right, defense, or remedy which a party may have with respect to third parties or the officer(s) whose action or inaction give rise to loss, claim or liability, including, but not limited to, an assertion that the officer(s) was acting beyond the scope of his or her employment.

WWRDGTF Intergovernmental Agreement: page 11 of

Cover or require indemnification or payment of any judgment against any individual or Agency for intentionally wrongful conduct outside the scope of employment of any individual or for judgment for punitive damages against any individual or Agency. Payment of punitive damage awards, fines or sanctions shall be the sole responsibility of the individual against whom said judgment is rendered and/or his or her Agency employer, should that employer elect to make said payment voluntarily. This Agreement does not require indemnification of any punitive damage awards or for any order imposing fines or sanctions.

#### **SECTION 11 – AMENDMENT**

This Agreement may be amended from time-to-time as deemed appropriate by the parties, provided that such amendment shall become effective only after it has been adopted in writing by authorized representatives of each of the parties.

#### **SECTION 12 - INTEGRATION**

This Agreement and the application contain all the terms and conditions agreed upon by the parties, except necessary operational agreements between the law enforcement agencies of the respective jurisdictions pursuant to Chapter 10.93 RCW. No other understandings, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind any of the parties. This Agreement shall expressly supersede all prior Agreements among the jurisdictions regarding WWRDGTF creation, operation, and administration.

#### **SECTION 13 – COUNTERPARTS**

This Agreement may be executed in counterparts.







## Corrections/Court Services Department Updates:

- ✓ <u>Service Providers, Programs, Grants & Essential Services</u>
- The County has requested several changes to proposed contract language in the *Medication for Opioid Use Disorder in Jails Program* agreement with the state Health Care Authority; waiting for HCA's response to those change requests. Once the contract is approved by HCA and the County, the jail will transition to a more robust Medication Assisted Treatment program.
- Adult Recovery Court census is low but most ARC clients are achieving success.
  - We have two ARC clients in Phase 3 (140 and 112 days clean respectively) who have maintained sobriety since day one.
  - Another ARC client in Phase 5 preparing to graduate who has maintained his sobriety throughout all five phases thus far (364 days)
  - Finally, another ARC client in Phase 5 nearing graduation who has had a path that is more typical with some slips and subsequent treatment modifications who nonetheless is preparing to graduate, has 142 days clean time as of the 3/8 ARC Docket (588 days).

## ✓ Legislative/Court/Jail Operations

- SB5122 (age of jurisdiction) is apparently stalled and has been placed into the Senate Rules "X" File, which makes it no longer eligible for consideration.
- Per CDC and WASPC, masks are still required in congregate care settings such as jails and detention facilities. Mask requirements remain in effect at the Jail and JJC currently.

## ✓ Personnel/Training/Recruitment

- WWSO Deputies Stites and Henderson held Defensive Tactics training sessions at Court Services for Corrections and Juvenile Detention Officers.
- On March 17<sup>th</sup>, I will participate on the City's Professional Panel to interview WWPD Chief applicants. The City could make a tentative offer to Chief Bieber's successor as soon as March 18<sup>th</sup>.
- Corrections' new sergeants Jabe Corier and Bodie Simpson scheduled to attend 1<sup>st</sup> Level Supervision this summer.


