The Board of Supervisors met in Session on the above date with the following members present: Leffler, Campbell, Dencklau, Carlson and Thode. Absent: None.

Moved by Dencklau, seconded by Leffler to approve the agenda as presented. Motion carried unanimously.

Moved by Leffler, seconded by Carlson to approve the February 13, 2018 meeting minutes. Motion carried unanimously

A Hearing was held on the first consideration to adopt Ordinance 052; an Ordinance repealing Ordinance Number 51 and Amendment 1 to Ordinance 51 in their entirety and replacing with Ordinance Number 52 Regulating the operation of All-Terrain Vehicles and Off-Road Vehicles in Webster County, Iowa. A letter of support was received and placed on file from Matt Cooper with an additional 65 signatures. (Copy on file in Auditor's Office) No oral comments were received.

Moved by Carlson, seconded by Dencklau to approve first consideration to adopt Ordinance 052 an Ordinance repealing Ordinance Number 51 and Amendment 1 to Ordinance 51 in their entirety and replacing with Ordinance Number 52 Regulating the operation of All-Terrain Vehicles and Off-Road Vehicles in Webster County, Iowa and further to set hearing dates for the second consideration on February 27, 2018 at 10:00 a.m. and the third consideration on March 6, 2018 at 10:00 a.m.. Moved by Carlson, seconded by Thode to approve setting public hearing on Fiscal Year 2019 Secondary Road Budget and Five Year Construction Program during the regular meeting of the Board of Supervisors at 10:00 A.M., Tuesday, March 27, 2018. Motion carried unanimously.
