






Statutory Maximum

Only the City or Library can use the available capacity, no other jurisdictions. If Yelm or the Library want to take more than 1% they have to go to the voters!


RCW 84.55.010 The limit factor is 1%, so each taxing district (cities, counties, towns, library districts, fire districts, etc.) is limited to 1%. The only other items that are statutorily allowed to increase a taxing district's levy is:

- New construction
- Property improvements
- Increases in the assessed value of state-assessed property
- Increases in assessed value of wind, solar, biomass, and geothermal facilities which generate electricity and are not included in the preceding areas listed

Nowhere is the statute does it state that a taxing district may add-in additional taxes forgone by other taxing districts. Eric Lowell, MRSC




How is the 1% Calculated? CITY OF YELM



To Caluclate a 1% Increase, you use the Prior Year Levy
Amount, Not the Prior Year

As Assessed Value Increases, Levy Rates will Decrease

A homeowner with a \$400,000 house would pay; \$400,000 X 1.1027 = \$405,080 divided by 1,000 = \$405.08/year in 2023

If the City took the 1% increase, the homeowner's tax would be:

New Levy Rate:(\$1,616,561.16+\$15,590)/1,596,237,125 times 1,000 = \$1.0225

\$400,000 X 1.0225 = \$409,000 divided by 1,000 = \$409.00/year in 2023 or an additional \$3.92/year.
