RESOLUTION NO. 2023-012

WHEREAS, the United States Department of Navy supplies civilian law enforcement agencies with surplus equipment to utilize in the performance of their duties; and

WHEREAS, the County of Yuba has a need for equipment that the Department of the Navy has in surplus, specifically night vision goggles and thermal cameras; and

WHEREAS, pursuant to the requirements of Yuba County Sheriff's Office Policy 404, a specialized weapons and tactics unit (SWAT) is comprised of personnel that are trained to provide support in handling critical field operations in which special tactics are necessarily deployed. These measures are beyond the capability of field officers, and are tasked to SWAT to ensure the safety of the public and department personnel. Often the incidents in which SWAT is deployed occur during hours of darkness, aiding the suspect in concealment and evasion. Utilizing the requested equipment, Thermal Imaging Cameras and Night Vision Goggles, will aid SWAT in operating safely in the darkness when necessary, allowing the team tactics and equipment to be utilized more effectively during all hours; and

WHEREAS, the Department of the Navy seeks to extend Naval Surface Warfare Center, Crane Division cooperation with civilian law enforcement officials to the maximum extent practicable, consistent with the needs of national security and military preparedness, the historic tradition of limiting direct military involvement in civilian law enforcement activities, and the requirements of applicable law. Pursuant to SECNAV Instructions 5820.7C "Cooperation with Civilian Law Enforcement" and NSWCCRANEINST 5700.1A "Law Enforcement Electro-Optics Loan Program".




