**RESOLUTION NO. 2023-032**

**WHEREAS**, on June 30, 2022, Governor Newsom signed Assembly Bill (AB) 178, which approved the State Budget Act of 2022, that established the Mobile Probation Service Centers Grant Program.

**WHEREAS**, as part of AB 178, \$20 million was set aside for the Board of State and Community Corrections (hereafter referred to as the BSCC), to award non-match grants to counties through the Mobile Probation Service Centers Grant Program, for the purpose of providing funding to County Probation Departments to purchase vehicles, equipment, telecommunications, and other technology needed to operate mobile probation service centers to assist probationers, particularly those individuals who are unhoused and struggling to meet probation requirements; and

**WHEREAS**, Yuba County has applied for and been approved for grant funding in the amount of \$494,742.00; and

**WHEREAS**, this resolution desires to have the Board of Supervisors ratify Yuba County applying for the grant, and to authorize and delegate authority to the Chief Probation Officer to execute the grant agreement and all other documents, receive and disperse funds in accordance with the grant terms and conditions, prepare for the project, construction of the project, administer the grant program, and project closeout; and

**WHEREAS**, the grant funds received hereunder shall not be used to supplant expenditures controlled by this body; and

**WHEREAS**, the Yuba County Probation Department agrees to abide by the terms and conditions of the Grant Agreement as set forth by the BSCC.

**NOW, THEREFORE, BE IT RESOLVED**, the Yuba County Board of Supervisors hereby ratifies the submission of the grant application for the BSCC Mobile Probation Service Centers Grant Program.

**BE IT FURTHER RESOLVED** that the Yuba County Board of Supervisors authorizes and delegates authority to the Chief Probation Officer to execute the Grant Agreement and all necessary related documents, accept and administer grant funding from BSCC Mobile Probation Service Centers Grant Program in accordance with the Grant terms and conditions.




