WHEREAS, California's Interagency Council on Homelessness within has made grant funds available for the Homeless Housing, Assistance, and Prevention (HHAP) Program Round 4; and

WHEREAS, building on the regional coordination created through previous HHAP funding, this fourth round of funding is intended to support local jurisdictions with a unified regional response to reduce and end homelessness; and

WHEREAS, applicants must submit an application for HHAP Program Round 4 funds and enter into an agreement in order to receive their allocation; and

WHEREAS, Yuba County's HHAP Program Round 4 grant allocation is \$876,750.05; and

WHEREAS, the HHSD Director submitted an application to receive the allocated HHAP Program Round 4 grant funds for Yuba County in the amount of \$876,750.05.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to enter into an Agreement with the Business, Consumer Services and Housing Agency for HHAP Program Round 4 grant funds for the term of July 1, 2022 through October 1, 2027 including subsequently extended term.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the HHAP Program Round 4; execute agreements, memorandums of understanding (MOUs) or amendments developed under the HHAP Program Round 4, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all HHAP Program Round 4 funds and any subsequent funds allocated or awarded for the stated period.

A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.




